STATEMENT OF THE CASES

In **Case No. 26003**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 34 and 35, Township 20 South, Range 27 East, Eddy County, New Mexico. This Unit will be dedicated to the **Cripple Creek 35/34 Fed #521H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 35 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 34.

In **Case No. 26004**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 34 and 35, Township 20 South, Range 27 East, Eddy County, New Mexico. This Unit will be dedicated to the **Cripple Creek 35/34 Fed #525H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 35 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 34.

The completed intervals of the Cripple Creek Wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as the operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
