STATEMENT OF THE CASES

In **Case No. 26027**, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 SE/4, the SE/4 SW/4, and Lot 4 (S/2 S/2 equivalent) of irregular Section 7, and the S/2 S/2 of Section 8, Township 20 South, Range 27 East, Eddy County, New Mexico. This unit will be dedicated to the **Fiero 8-7 Fed Com 204H** well, which will be drilled from a surface

hole location in the NW/4 NW/4 (Unit D) of Section 16 to a bottom hole location in Lot 4 (SW/4 SW/4 equivalent) of irregular Section 7.

In **Case No. 26028**, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 SE/4, the NE/4 SW/4, and Lot 3 (N/2 S/2 equivalent) of irregular Section 7, and the N/2 S/2 of Section 8, Township 20 South, Range 27 East, Eddy County, New Mexico. This unit will be dedicated to the **Fiero 8-7 Fed Com 203H** well, which will be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 16 to a bottom hole location in Lot 3 (NW/4 SW/4 equivalent) of irregular Section 7.

The completed intervals of the Fiero 8-7 Fed Com Wolfcamp Wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as operator of the Units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
