**MOTION TO AMEND PRE-HEARING ORDER**

3. The Pre-Hearing Order setting Case Nos. 25912-25915 for a contested hearing on July 7, 2026 should thus be amended to add AO II Case No. 26186, to also be heard on July 7, 2026.
