APPLICANT’S STATEMENT OF THE CASES

In these consolidated cases, OXY seeks orders pooling for the referenced acreage, all in Township 23 South, Range 32 East, NMPM, Lea County, New Mexico, as follows:

- Under **Case No. 26127**, OXY seeks to pool all uncommitted interest owners in the Upper Wolfcamp formation (WC-025 G-08 S243217P;UPR WOLFCAMP (oil [98248]) underlying a standard 320-acre, more or less, horizontal well spacing unit comprised of the E/2 of Section 29, and dedicate the unit to the proposed **Mercury 29**

Federal 34H (API No. 30-025-55211) u-turn well, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 29, with a first take point in the SW/4 SE/4 (Unit O) of Section 29, and a last take point in the SE/4 SE/4 (Unit P) of Section 29.

- Under **Case No. 26128**, OXY seeks to pool all uncommitted interest owners in the Lower Wolfcamp formation (WC-025 S233206C; LWR WOLFCAMP (gas) [98393]) underlying a standard 320-acre, more or less, horizontal well spacing unit comprised of the E/2 of Section 29, and initially dedicate the unit to the proposed **Mercury 29 Federal 46H** (API No. 30-025-55944) well, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 29, with a first take point in the SW/4 SE/4 (Unit O) of Section 29, and last take point in the NW/4 NE/4 (Unit B) of Section 29; and **Mercury 29 Federal 48H** u-turn well, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 29, with a first take point in the SE/4 SE/4 (Unit P) Section 29, and a last take point in the SW/4 SE/4 (Unit O) of Section 29.

The completed interval for the wells will comply with statewide setbacks for oil and gas wells, respectively. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.
