JOINT NOTICE OF DISMISSAL OF APPLICATIONS

Permian Resources Operating, LLC (“Permian Resources”) and MRC Permian Company (“MRC”), by and through undersigned counsel, hereby provide notice that they are dismissing Case Nos. 26233, 26234, 26332, 26333, and 26335. In support of this Notice, Permian Resources and MRC state as follows.

1. Permian Resources filed Case Nos. 26233 and 26234 (“PR Goodfellas Cases”) on June 5, 2026.
2. MRC filed its notice of objection to the PR Goodfellas Cases on June 29, 2026.
3. MRC then filed Case Nos. 26332, 26333, and 26335 (“MRC Bill Wilshusen Cases”) on July 7, 2026.
4. Permian Resources filed its notice of objection to the MRC Bill Wilshusen Cases on July 21, 2026.
5. The Division held a status conference in the PR Goodfellas Cases on July 23, 2026 and set all of the cases for a final status conference on August 20, 2026.
6. The parties have subsequently engaged in productive negotiations and have reached an agreement to dismiss their respective cases.

WHEREFORE, Permian Resources and MRC respectfully provide notice that they are dismissing Case Nos. 26233, 26234, 26332, 26333, and 26335.
