APPLICATION

Matador Production Company, ("Matador") (OGRID No. 228937), through its undersigned attorneys, hereby makes application to the Oil Conservation Division to amend the initial well under Order R-14432. In support of this application, Matador states:

1. Division Order R-14432, entered on September 1, 2017, created a 155.29-acre spacing and proration unit consisting of the N/2 S/2 of Section 19, Township 20 South, Range 29 East, NMPM, in Eddy County, New Mexico. This order further pooled the uncommitted interests in the Bone Spring Formation (Russell; Bone Spring Pool (52805)) in this spacing and proration unit (the "Unit") and dedicated the Unit to the **Stebbins 19 Federal Com No. 133H** (API No. 30-015-44174), a horizontal well to be drilled from a surface location 2347 feet from the South line and 520 feet from the East line (Unit I) to a bottom hole location 1870 feet from the South line and 240 feet from the West line (Lot 3) of Section 19.

2. Since the entry of Order R-14432, Matador has changed the initial well within the Bone Spring formation. The spacing unit and the pool remain the same as designated under Order R-14432.

3. The spacing unit will be the **Stebbins 19 Federal Com No. 123H** (API No. 30-015-44170), a horizontal well to be drilled 2317 feet from the South line, 520 feet from the East

line (Unit I) to a standard bottom hole location 1870 feet from the South line, 240 feet from the West line of Section 19.

WHEREFORE, Matador Production Company requests that this application be set for hearing before an Examiner of the Oil Conservation Division on November 30, 2017, and, after notice and hearing as required by law, the Division amend the initial well dedicated to the spacing unit under the terms of existing Division Order R-14332.
