



Gentlemen:

Gulf Oil Corporation respectfully requests an Examiner Hearing for compulsory pooling of all working interests and royalty interests underlying Section 12, T-23-S, R-24-E in the Rock Tank Upper and Lower Morrow Gas Pools, Eddy County, New Mexico, for the purpose of forming a standard 640-acre gas proration unit covering Section 12. Applicant proposes to drill a well at a standard location 1650 feet from the north line and 1650 feet from the east line of Section 12 and will request a 150% risk penalty factor be granted.

In support of this application, the following facts exist:

- (1) The Commission, by Order No. R-3428 in Case No. 3727, approved 640-acre spacing for the Rock Tank Upper and Lower Morrow Gas Pools.
- (2) The rules provide each well located within one mile of these pools shall be located on a standard unit containing 640 acres consisting of a governmental section.
- (3) The rules also provide that each well shall be located no nearer than 1650 feet to the outer boundary of the section.
- (4) Applicant is the major Working Interest Owner in the W/2 Section 12 and also has a working interest in the E/2 of this section.
- (5) Applicant has not been successful to date in obtaining the consent of all parties to drill a well and form the standard 640-acre unit for this Section 12.


