- Q Would you state your name, please?
- A Byron Greaves.
- Q Would you spell that, please?
- A B-Y-R-O-N G-R-E-A-V-E-S.
- Q By whom are you employed and in what position,

A I am employed by Flag-Redfern Oil Company as Petroleum Engineer.

Q Have you ever testified before the Oil

Conservation Commission or one of its Examiners?

- A No, sir, I have not.
- Q For the benefit of the Examiner would you briefly outline your expertise and experience as a Petro-leum Engineer?

A I was graduated in August, 1958, from Texas

Technological University with a Bachelor of Science in

Petroleum Engineering. Upon graduation I joined Texaco,

Incorporated, and was employed in engineering assignments
throughout the Permian Basin until leaving them January 1,

1965. I then joined Great Plains Land Company as a

Petroleum Engineer and was employed by them until October

of 1969 at which time I assumed my current position.

Q In connection with your work for Flag-Redfern do you have anything to do with the area involved in this Application?

A Yes, sir. As Petroleum Engineer I'm responsible for recommending in conjunction with the geological staff the drilling and development of West Sawyer-San Andres Field.

MR. KELLAHIN: Are the Witness' qualifications acceptable?

MR. NUTTER: Yes, they are.

BY MR. KELLAHIN:

Q Mr. Greaves, what does the Applicant propose in this case?

A Flag-Redfern requests permission to drill in the Belbry 23 Well No. 4 to be located 1980 from the South line and 660 from the East line of Section 23, 9 South, 37 East and that the well be granted an assignment of 40 acres upon completion. The West Sawyer-San Andres Field pool rules provide for 80 acre development and provide that the initial well in each unit shall be drilled in the Northwest or Southeast of a Governmental quarter section. This would place the actual location in the Southeast Southeast of Section 23.

- Q Now, is this the first well that will be drilled on the unit?
 - A Yes, sir.
- Q So for that reason it would be an exception to the rule?
 - A That's correct.
- Q Now referring to the plat which appears in the Applicant's Exhibit No. 1, would you discuss the information shown on that?
 - A Yes, sir, the proposed well as shown of

interest to your Section 24 is classified as the Sawyer San Andres Pool, Section 23, 26 and 27 and 22 are in the West Sawyer-San Andres Pool. These pools, as you see, will merger. The Sawyer-San Andres Pool provides for development on 40 acres for an oil well. The West Sawyer-San Andres Pool provides for 80 acre development.

- Q With the election to drill on 40, is that correct?
 - A Yes, that is correct.
- Q Now, turning to the structure map of the Exhibit, would you discuss that?

location would be as indicated 801 feet from the South line and from the East line. Our geological interpretation of this location is that the top of the Pie Zone as shown on this structure map would be a subsea eight minus eight fifty-eight. The lowest producing well in this immediate area of the San Andres Reservoir is the Green and Funk Well over in Section 24 which produced at a pie marker of subsea minus 847. The only dry hole in the area which will confirm the possibility of water is in Section 26 of the Southeast Southeast which is below Mack No. 1 Federal 26.

- Q I believe you mean the Southwest Southwest?
- A Excuse me, yes, sir, Southwest Southwest.

 This well was drilled in February of 1971, encountered the pie at minus 888, but set pipe and attempted completion and recovered water with a show of oil.
- Q Is the structural provision your reason for asking for the unauthorized location in this case?
 - A That's correct.
- Q What acreage do you propose to dedicate to the well?
- A The North Northeast quarter of the Southeast quarter, Unit I of Section 23.
 - Q Only the 40 acres?
 - A Yes, sir, only the 40 acres.
- Q Now, do you have any plans to drill in the standard location as indicated on your structure map?
- A Yes, sir, pending development of placement of Belbry 23 No. 4, it is our plan to develop the area on 40 acres and we would continue with development avoiding the location in the Southeast Southeast until geological interpretation assured that we could make a commercial well.
 - Q In your opinion is all of the 40 acres you propose

to dedicate to the well productive from the Sawyer Pool?

- A Yes, based on the off-set wells.
- Q Now, turning to the summary of well information, do you have any comments on that, Mr. Greaves?

I might comment on that with the cross section. The first cross section covers the well as indicated on the map and cross sections 1 through 7, and the history of these wells along with its structural position, starting with the left, on the left side of the cross section, the Oil Development Company of Texas, Santa Fe Railroad No. 14. This well is currently producing 73 percent water based on the latest production information as reported to the Commission. The next well on the cross section, Meadco John Cox, is USM No. 2, currently producing 76 percent water. The third well on the cross section is Meadco properties, Arco No. 1 which is in Northwest Northwest Section 26, 70 percent water. Flag-Redfern's Yates 69 Federal No. 1, which is structurally a little higher on this Section, is currently producing 17 percent water, and then we have completed the Allied No. 93 over in Section 24, which would be the east off-set to the proposed location, in December the well is producing 67 percent water. The cross section indicates that the designated

locations under the existing field rules would be 14 foot long to Allied 93 Well which is in Section 24. This well, as indicated by well tests, is 67 percent water.

- You say that is the orthodox location or your proposed location?
- The orthodox location would be 14 feet long, yes, sir.
- And do you consider that as making in a risky venture to drill at this time?
 - That's correct.
- Do you have any further comment on the cross section?
 - No, sir, I can't think of anything.
- Now, who is the owner of the acreage off-setting your proposed location, the operators?
- Section 24, Flag-Redfern is operating under a farm-out to Union Texas Petroleum, and the Allied 93, the Well has been approved by the Commission, and will be started before March 18th.
 - In Section 23, is Flag-Redfern the only operator?
 - Yes, sir, that is correct.
- And will the drilling at the location you propose have any adverse effect on any other operator?
 - In my opinion, no.

- Q Have you been able to establish the oil-water contact in this pool?
 - A No, sir, we have not.
- Q How would you refer to this, as a transitional water zone?
- A Yes, sir. The cross section would indicate that wells encountering the high zone below a datum of 840 would produce water in excess of 50 percent, 40 to 50 percent. The point at which 100 percent water would occur is, in our opinion, dependent upon probability and by drilling at a location 840 or below you would be taking a chance on 100 percent water.
- Q Was Exhibit 1 and the Exhibits contained therein prepared by you or under your supervision?
 - A Yes, sir.
- Q At this time I would like to offer into evidence Exhibit No. 1.

CROSS EXAMINATION

BY MR. NUTTER:

- Q Mr. Greaves, it is not mentioned in the Application nor in the legal notice for this case that you propose a 40 acre nonstandard unit, but that is your proposition, is that correct?
 - A Yes, sir, that is correct.
- Q You are aware that at least administrative approval for the nonstandard unit would have to be obtained?
 - A Yes, sir, right.
- Q And you propose to dedicate only the 40 acres, being the Northeast to the Southeast of Section 23 to the well?
 - A Yes, sir.
- Q Now, you mentioned the water cuts on a number of wells on your cross section 1 to 7. How about going up

 North then, and the other wells on your other cross sections what is the water cut-off?
- A Yes, sir, on the last cross section and turning back to the summary of well information, the first well on the left is the Meadco Arco No. 1 which we talked about before. This well is in Section 26, Northwest

- Q That had a 70 percent cut-off?
- A That's right, and then the next well is again the Flag-Redfern Oil Company-Yates Federal which was again mentioned before at 17 percent.
 - Q How about Flag-Redfern No. 1 Belbry 23?
- A All right, sir. The well was completed actually with a water cut of 41 percent, however, current well tests indicate 9 percent.
 - Q So the water cut has gone down?
- A Yes, sir. There may have been some acid water in that initial contention.
 - Q How about your Marathon Federal?
- A The Marathon Federal No. 1 was completed with a water cut of 2 percent and currently produces 11 percent water, 11 barrels of oil and 1 barrel of water.
- Q So those two wells are going up the structure, and you are getting water?
 - A That's correct, yes, sir.
- Q And the normal location which you are seeking to avoid here would probably be a very high water content?
- A That's correct. That is our current interpretation of the structure.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on February 27, 1974, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 6th day of March, 1974, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Flag-Redfern Oil Company, seeks, as an exception to the West Sawyer-San Andres Special Pool Rules, authority to drill an oil well at an unorthodox location 1980 feet from the South line and 660 feet from the East line of Section 23, Township 9 South, Range 37 East, Lea County, New Mexico.
- (3) That said unorthodox location is proposed in order to avoid an excessive water cut which might occur at a standard location.
- (4) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the oil in the West Sawyer-San Andres Pool and will otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That an exception to the West Sawyer-San Andres Special Pool Rules is hereby granted authorizing applicant to drill an oil well at an unorthodox location 1980 feet from the South line and 660 feet from the East line of Section 23, Township 9 South, Range 37 East, NMPM, Lea County, New Mexico.

(2) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.

Flag-Redfern Oil Company requests approval to drill the Bilbrey "23", Well No. 4, to be located 1980' FSL and 660' FEL of Section 23, 9S, 37E, and that the well be granted an assignment of 40 acres upon completion.

The West Sawyer-San Andres special pool rules provide that the first well on each 80-acre unit shall be drilled in the NW/4 or the SE/4 of a governmental quarter section. The well shall be located within 200 feet of the center of governmental quarter-quarter section.


Under this requirement, the well would be located 801' FSL and 801' FEL of the section. Our current structural interpretation indicates that the well would encounter the San Andres Pi marker at a datum of -858' subsea. The lowest commercial producer in the immediate area encountered the Pi marker at a datum of -847' subsea.


The San Andres reservoir contains a transitional water zone, and a definite water-oil contact has not been established. As indicated by the attached cross sections and Summary of Well Information, a structural position with the Pi marker below a datum of -840' subsea results in a high water cut, and the only dry hole in the immediate area, The Wil-Mc Corp. Federal 26 No. 1 M, 26-95-37E, encountered the Pi marker at a datum of -888' subsea. Completion was attempted in the top of the porosity from a datum of =1060' to 1066' subsea, and final recovery was water with a show of oil.

The drilling of this well at the required location with the anticipated low structural position results in considerable risk. It is possible that this location can be successfully completed, however, it is requested that approval be granted to drill in the unorthodox location prior to the development of the designated location.


