THE APPLICATION OF CONTINENTAL OIL COMPANY FOR AN ORDER GRANTING APPROVAL OF AN EXCEPTION PURSUANT TO RULE 7 (a) OF ORDER NO. R-370-A IN ESTABLISHMENT OF AN UNORTHODOX GAS PRORATION UNIT OF 40 CONTIGUOUS ACRES CONSISTING OF THE NE/4 NW/4 OF SECTION 8, TOWNSHIP 20 SOUTH, RANGE 37 EAST, NMPM., LEA COUNTY, NEW MEXICO, IN THE EUMONT GAS POOL.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a. m., on June 16, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NOW, on this day of , 1954, the Commission, a quorum being present, having considered the records and testimony adduced, and being fully advised in the premises,

FINDS:

- (1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.
- (2) That pursuant to provisions of Rule 7 (a) of Order No. R-370-A, the Commission has power and authority to permit the formation of a gas proration unit consisting of other than a legal quarter section after notice and hearing by the Commission.
- (3) That applicant, Continental Oil Company, is the owner of an oil and gas lease in Lea County, New Mexico the land consisting of other than a legal quarter section, and described as follows, to-wit:

TOWNSHIP 20 SOUTH, RANGE 37 EAST, NMPM. NE/4 NW/4 Section 8

containing 40 acres, more or less.

- (4) That applicant, Continental Oil Company, has a producing well on the aforesaid lease known as Britt B-8, No. 1 located 660' from the North line and 1980' from the West line of Section 8, Township 20 South, Range 37 East.
- (5) That the aforesaid well was completed and in production prior to January 1, 1954, the effective date of Order No. R-370-A and is located within the limits of the pool heretofore delineated and designated as the Eumont Gas Pool.

- (6) That it is impractical at this time to pool applicant's said lease with adjoining acreage in the NW/4 of Section 8, Township 20 South, Range 37 East and that the owners of adjoining acreage in said quarter section have not objected to the formation of the proposed proration unit of 40 acres.
- (7) That unless a proration unit consisting of applicant's aforesaid acreage is permitted, applicant will be deprived of the opportunity to recover its just and equitable share of the natural gas in the Eumont Gas Pool.
- (8) That creation of a proration unit consisting of the aforesaid acreage will not cause but will prevent waste and will protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of Continental Oil Company for approval of an unorthodox proration unit consisting of the following described acreage

TOWNSHIP 20 SOUTH, RANGE 37 EAST, NMPM. NE/4 NW/4 of Section 8

be and the same is hereby approved, and a proration unit consisting of aforesaid acreage is hereby created.

(2) That applicant's well, Britt B-8, No. 1, located in the NE/4 NW/4 of Section 8, Township 20 South, Range 37 East, NMPM., shall be granted an allowable from January 1, 1954 in the proportion that the above described 40 acre unit bears to the standard or orthodox proration unit for said pool, all until further order of the Commission.

IN THE MATTER OF THE APPLICATION OF CONTINENTAL OIL COMPANY FOR AN EXCEPTION TO RULE 7(A) OF ORDER NO. R-370-A, FOR AN UNORTHODOX GAS PRORATION UNIT CONSISTING OF APPROXIMATELY 40 ACRES DESCRIBED AS THE NE/4 NW/4 SECTION 8, TOWNSHIP 20 SOUTH, RANGE 37 EAST, N.M.P.M. LEA COUNTY, NEW MEXICO, FOR ITS BRITT B-8 NO. 1 WELL IN THE EUMONT POOL

APPLICATION

Comes now Continental Oil Company, hereinafter called "applicant", and respectfully requests an exception to Rule 7(a) of Order No. R-370-A and approval by the Commission of an unorthodox gas proration unit for applicant's Britt B-8 No. 1 well as described in the caption hereof, and in support thereof would show the following:

- 1. Applicant is joint owner and is the operator of a lease known as the Britt "B" Lease, covering the NE/4 NW/4, Section 8, Township 20 South, Range 37 East, N.M.P.M., Lea County, New Mexico, in addition to other lands outside said Section 8.
- 2. Applicant drilled its Britt B-8 No. 1 well at a location described as 660 feet from north and 1980 feet from west lines of Section 8 on said lease and completed said well on February 14, 1937, as an oil well producing from the Grayburg Formation. Said well subsequently was plugged back and recompleted as a gas well producing from a depth interval of approximately 2900 to 2962 feet.
- 3. Said well is located within the limits of the Eumont Gas Pool as defined by the Oil Conservation Commission and is the only well producing from said pool on the 40-acre unit described above.
- 4. Pooling of these lands with lands outside the above described unit to form gas proration units consisting of governmental quarter sections has not been accomplished to date. Operators owning interests within this quarter section have been contacted for the purpose of investigating the feasibility of effecting a communitization. The purpose of this application is to secure an allowable to the above mentioned well, pending formation of a larger unit provided such communitization is determined to be practicable.
- 5. The above described unit consists of less acreage than a standard proration unit, lies wholly within a regular quarter section and contains a well which was capable of producing gas into a gas transportation facility prior to January 1, 1954.

Wherefore, applicant respectfully requests the Commission to place this matter on its docket for hearing at an early date in June, 1954, cause due notice to be given thereof and upon hearing, enter an order approving an unorthodox gas proration unit for applicant's Britt B-8 No. 1 well as described above.
