Gentlemen:

Pursuant to the provisions of Section (10) of Order No. R-520, as entered by the Commission on August 12, 1954, in Case No. 673, Gulf Oil Corporation files this its application for a hearing to have the wells hereinafter described excepted from the rule set forth in Section (10) of Order No. R-520, which provides that no gas, either dry or casinghead gas, shall be flared or vented in the fourteen (14) pools designated in the Order unless specifically authorized by order of the Commission after notice and hearing.

The wells with respect to which Gulf Oil Corporation desires to obtain an exception from the above rule and with respect to which its application for hearing is herein made are described below by pools in which such wells are located.

ARROWHEAD OIL POOL

A. H. Leonard "D" (State) Lease Wells Nos. 1 and 2

Well No. 1 is 330' from the East line and 1650' from the North line of Section 3, T-22-S, R-36-E, Lea County, New Mexico.

Well No. 2 is 330' from the East line and 330' from the North line of Section 3, T-22-S, R-36-E, Lea County, New Mexico.

B. H. T. Mattern "A" (State) Lease Well No. 2

This well is located 1650' from the East line and 1650' from the South line of Section 24, T-21-S, R-36-E, Lea County, New Mexico.

C. W. A. Ramsay "B" (State) Lease Well No. 1

This well is located 1980' from the West line and 1980' from the North line of Section 25, T-21-S, R-36-E, Lea County, New Mexico.

COOPER JAL OIL POOL

A. J. F. Janda "A" (State) Lease Well No. 3

This well is located 1650' from the South line and 990' from the East line of Section 4, T-23-S, R-36-E, Lea County, New Mexico.

B. J. F. Janda "E" (State) Lease Well No. 3

This well is located 360' from the North line and 330' from the East line of Section 21, T-23-S, R-36-E, Lea County, New Mexico.

EAVES POOL

A. Vinson Ramsay (State) Lease Well No. 1

This well is located 660' from the East line and 660' from the South line of Section 12, T-26-S, R-36-E, Lea County, New Mexico.

MONUMENT OIL POOL

A. J. W. Smith Lease Wells Nos. 1 and 2

Well No. 1 is located 660' from the East line and 1980' from the North line of Section 34, T-19-S, R-36-E, Lea County, New Mexico.

Well No. 2 is located 660' from the East line and 660' from the North line of Section 34, T-19-S, R-36-E, Lea County, New Mexico.

SOUTH EUNICE OIL POOL

A. J. F. Janda (State) "F" Lease Wells Nos. 1 and 2

Well No. 1 is located 660' from the West line and 660' from the South line of Section 4, T-22-S, R-36-E, Lea County, New Mexico.

Well No. 2 is located 660' from the West line and 1980' from the South line of Section 4, T-22-S, R-36-E, Lea County, New Mexico.

LANGLIE-MATTIX OIL POOL

A. Vinson Ramsay (State) Lease Well No. 3

This well is located 660' from the South line and 660' from the West line of Section 36, T-25-S, R-37-E, Lea County, New Mexico.

**B. Carter Eaves Lease Wells Nos. 1, 2 and 3**

Well No. 1 is located 660' from the North line and 1980' from the West line of Section 6, T-24-S, R-37-E, Lea County, New Mexico.

Well No. 2 is located 1980' from the North line and 1980' from the West line of Section 6, T-24-S, R-37-E, Lea County, New Mexico.

Well No. 3 is located 660' from the South line and 1917' from the West line of Section 6, T-24-S, R-37-E, Lea County, New Mexico.

**PENROSE SKELLY POOL**

**A. R. E. Cole (State) "C" Lease Well No. 1**

This well is located 330' from the East line and 1980' from the North line of Section 32, T-22-S, R-37-E, Lea County, New Mexico.

Gulf Oil Corporation states that there are various reasons why the "no flare rule" should not be invoked as to each of the sixteen (16) wells above described and that if its application is granted, it will upon hearing present evidence and testimony in support of its belief that the Commission should grant an exception to Rule (10) of the Order as to each of the sixteen (16) wells.

WHEREFORE, Gulf Oil Corporation requests that its application for hearing be granted and that due notice thereof be given.
