#### TRANSCRIPT OF HEARING

MR. MACEY: The next case on the docket is Case 909.

MR. WATSON: Neal B. Watson, Artesia, New Mexico, representing the applicant, Texas Trading Company. I have as my witness, Mr. H. B. Thomas, Superintendent of the Texas Trading Company.

In the beginning, if the Commission please, I would like to amend the application, which is for a "five-spot" location on the Texas Trading Company's Grier Covernment lease, to change the well location from a site 1345 feet from the south and west lines of Section 29, to a site 1412 feet from the south and west lines.

The reason for that change, as will be brought out by Mr. Thomas, on the actual survey of the location in preparation for the hearing, it developed that the site requested was almost directly under the electric transmission line in the field, and it would be a hazard to drill the well at that particular location.

Also, at this time I would like to file with the Commission, consent of the offset owners, the first one being by Carper Drilling Company, operator of the offset leases to the north and east, and the consent of Mr. John Fidel, where of the offset lease to the west.

#### H. V. THOMAS,

called as a witness, having been first duly sworn, testified as follows:

#### DIRECT EXAMINATION

#### By MR. WATSON:

- Q Will you state your name, please?
- A H. V. Thomas.
- Q Are Julian official of the Texas Trading Company, Inc., the applicant in this case?
  - A I am.
  - Q What position do you hold?
  - A General Superintendent.
  - Q How long have you held that position?
  - A Twenty-seven years.
- Q You are familiar with the Texas Trading Company Government Lease, Las Cruces 060723?
  - A Tain.
- Q That covers the southwest quarter of Section 29, Township 16 South, Range 31 East, NMPM, Eddy County, New Mexico?
  - A Yes.
  - Q In what field is that in?
  - A Square Lake.
  - Q Will you state just briefly the wells, giving the location
- of the wells and the well numbers on that lease, please?

A Well, that is, Grier No. 1 would be in the southwest of the southwest, and Grier No. 2 would be in the southeast of the southwest. Grier No. 4 would be in the northeast of the southwest, and Grier No. 3 would be in the northwest of the southwest.

- Q About what time were those wells drilled?
- A About November 142.
- Q That is when the No. 1 was completed?
- A Yes.
- Q The rest of them were drilled thereafter in '42 and '43?
- A Yes.
- Q What is the production from those holes at the present time, the approximate daily production?
- A I would say they would average around four barrels, possibly ten barrels for Grier No. 4, which would be in the northeast of the southwest.
  - Q From what formation are those wells producing, Mr. Thomas?
  - A I would say San Andres sand. .
- Q Would you state whether or not that formation is a tight formation or --
  - A (Interrupting) Relatively tight.
- Q The Texas Trading Company has filed its application to drill a five-spot location at 1/12 feet from the south line and 1/412 feet from the west line of Section 29. What are the reasons of the Texas Trading Company for this application to drill this well?

A Relatively speaking we have been making some general inquiries throughout the Square Lake Field, and we have found out from various companies such as Sinclair, the Burnham Oil Company, the Carper Drilling Company and Zuppy and Zuppy, Tulsa, Oklahoma, that they have been sand fracking some new wells, and old wells and new wells, and have had some good results on some wells, and some wells they have had poor results. It seems that the engineers are advising them to drill through these various formations in the San Andres's pay, which would be known as 5, 6, 7 and 8, and 8 is commonly called the Lovington sand. We propose to drill a well and complete, run pipe through and shoot out with land wells, and according to our engineers, sand frac these wells as to a kind of a trial test.

- Q As I understand it, Mr. Thomas, from your testimony there, it is your information, from an engineering standpoint, that it would not be practical to try to sand frac these existing wells?
  - A That is right.
- Q And your results would be better if you would drill a new well and sand frac that new well?
  - A That is right.
- Q You are not asking the Commission for any additional allowable on account of the drilling of this well?
  - A No.
- Q At the time the application was filed, the location was 1345 feet from the south and west lines of Section 29. You desire now to amend that application to show the location to be 1412 feet from the south and west lines, for what reason, Mr. Thomas?

A Well, when we made that location, as I understand, the Commission requires you to move a five-spot and favor one or the other particular 40's that is involved in 160. We propose to drill

order to establish this location, particularly for one reason, to charge the amount of recoverable oil on that particular 40.

When we made the survey we got out there and immediately found out it came right underneath a high line. We have been very fortunate in trying to get electricity into the Square Lake Field. We didn't feel that we wanted to put the high line out, any trouble to come over there and move a big high tension line cause of 100 feet northeast. We thought it would be all right with the Commission, in order that we might move that location rather than have those people go to all that trouble to move that line, when there was only 100 feet involved.

Q Mr. Thomas, do you know the offset lease owner, oil and gas lease owner to the south, having this 160 acres?

A That is the Texas Trading Company, that would be the State, in 32, 16, 31, it would be the northwest of the northwest, No. 1; the northwest of the northwest No. 2.

- Q That is the Texas Trading Company's State of New Mexico cil and gas lease?
  - A That is right.
  - Q The offset owner to the west of your Grier Lease --
  - A (Interrupting) Is the northwest --
- Q (Interrupting) No, the offset owner to the west of the Grier Lease?
  - A John Fidel.
- Q On the north and east side of the Grier Lease, who is the offset owner?
  - A Carper Drilling Company.

Q Mr. Thomas, have you made application to the United States Geological Survey for permission to drill this well?

A Yes.

Q Do you have that permission from the United States Geological Survey, subject to obtaining the permission of the Oil Conservation Commission of New Mexico?

A Yes.

MR. WATSON: Does the Commission have any questions?

MR. RHODES: Just one. Are there any other five-spot locations in this area?

A In the same pool, there is a well in, I believe it is 16, 30, 31. I am not sure what the description of the well is, but it would be the Burnham Oil Company, yes.

MR. WATSON: That is all.

MR. MACEY: Anyone else have a question of the witness? If no further questions the witness may be excused.

(Witness excused.)

MR. WATSON: Apparently there is no opposition to the application. I have prepared a tentative form of order.

MR. MACEY: Thank you. Does anyone have anything further in this case?

GOVERNOR STMMS: Let the record show the trial amendment was allowed and the two exhibits were accepted.

MR. MACEY: We will take the case under advisement.

#### BY THE COMMISSION:

This cause came on for hearing at 1:00 P.M., May 19, 1955, at Santa Fe, New Mexico, having been continued from May 18, 1955 at 9:00 A.M., before the Oil Conservation Commission of the State of New Mexico, hereinafter referred to as the "Commission".

NOW, on this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 1955, the Commission, a quorum being present, having considered the records and testimony adduced, and being fully advised in the premises,

#### FINDS:

- 1. That due notice of the time and place of hearing, and the purpose thereof, having been given as required by law, the Commission has jurisdiction in this case and the subject matter thereof.
- 2. That the acreage involved is public domain lands of the United States of America, leased to the Texas Trading Co., Inc. under Government Oil and Gas Lease Las Cruces 060723, and covering the SW of Section 29, Township 16 South, Range 31 East, N.M.P.M., in Eddy County, New Mexico, and in the Square Lake Field.
- 3. That the Texas Trading Co., Inc. is the owner of the entire working interest in said oil and gas lease and has four wells located on said 160 acre tract, with the location and the names of the wells being as follows:

Texas Trading Co., Inc. No. 1 Well, SW4SW4 Section 29, Township 16 South, Range 31 East, N.M.P.M.

Texas Trading Co., Inc. No. 2 Well, SEtSWt Section 29, Township 16 South, Range 31 East, N.M.P.M.

Texas Trading Co., Inc. No. 3 Well, NW&SW& Section 29, Township 16 South, Range 31 East, N.M.P.M.

Texas Trading Co., Inc. No. 4 Well, NELSW Section 29, Township 16 South, Range 31 East, N.M.P.M.

4. That said wells at this time are producing, and the approximate daily production of oil from said wells is as follows:

Well No. 1, SW\(\frac{1}{2}\)SW\(\frac{1}{2}\)SW\(\frac{1}{2}\)SE\(\frac{1}{2}\)SW\(\frac{1}{2}\)Section 29 - 2\(\frac{1}{2}\) barrels per day Well No. 3, NW\(\frac{1}{2}\)SW\(\frac{1}{2}\)Section 29 - 5 barrels per day Well No. 4, NE\(\frac{1}{2}\)SW\(\frac{1}{2}\)Section 29 - 10 barrels per day.

- 5. That Texas Trading Co., Inc. filed its Application to drill a "five-spot" well at a location 1345 feet from the south and west lines of said Section 29, Township 16 South, Range 31 East, N.M.P.M., and, at the hearing, by and with the consent of the Commission, amended its said Application to apply for approval to drill said well 1412 feet from the south and west lines of said Section 29, Township 16 South, Range 31 East, N.M.P.M., by reason of the fact that the proposed location of 1345 feet would be near enough to the electric transmission line of the Rural Electrification Cooperative to cause a hazard in drilling at such location.
- 6. That Texas Trading Co., Inc. desires to drill said Grier No. 5 Well as a "five-spot" location, for the following reasons, to wit:
  - (a) That it considers said well necessary to adequately drain the 160 acre tract, by reason of the tightness of the formation; and
  - (b) That said well is to be drilled to the bottom of the San Andreas Formation and, in drilling said well, sandfracting or other methods will be used on an experimental or test basis, to test methods of completion not in use in the industry at the time the original four wells were drilled.
- 7. That applicant is not requesting any additional allowable for the forty acre tract on which said well will be drilled.
- 8. That said proposed Grier No. 5 Well will not be located near enough to the boundary line of any adjoining lease owner so as to require notice or consent of any adjoining lease owner, but the operators of the adjoining leases and owners of offset acreage have offered no objection to petitioner's Application and have, in fact, filed their written consent thereto.
- 9. That the irregular location of Texas Trading Co., Inc. proposed Grier No. 5 Well, at a site 1412 feet from the south and west lines of Section 29, Township 16 South, Range 31 East, N.M.P.M., in the Square Lake Field, is not prejudicial to any adjoining lease owner or detrimental to any lease interests in said Field, and should be granted by the Commission.

IT IS, THEREFORE, ORDERED:

That the Application of Texas Trading Co., Inc., as amended, for an order approving its projected Grier Well No. 5 as a "five-spot" location, at a site 1412 feet from the south and west lines of Section 29, Township 16 South, Range 31 East, N.M.P.M., in the Square Lake Field, be, and it hereby is, granted, and the location of said well is hereby approved.

COMES NOW Texas Trading Co., Inc., by Neil B. Watson, its attorney, and makes application to the New Mexico Oil Conservation Commission for administrative approval of a non-standard well location, and makes the following statements: -

- 1. That the complete legal description of the acreage involved is the SWL of Section 29, Township 16 South, Range 31 East, N.M.P.M., in Eddy County, New Mexico, which is Government Oil and Gas Lease Las Cruces 060723.
- 2. That the location and names of the wells on said lease are as follows:

3. That Texas Trading Co., Inc., owner of said lease, 1412 desires to drill a well 1345 feet from the south line of said quantid on Section 29, Township 16 South, Range 31 East, N.M.P.M., and 1412 feet from the west line of said Section 29, Township 16 South, Range 31 East, N.M.P.M., which said well will be located in the NEtSWt of said Section 29, Township 16 South, Range 31 East, N.M.P.M., where the No. 4 Well is presently producing.

That said No. 4 Well is now producing approximately ten (10) barrels per day, and this Application is not made for any additional allowable, but Texas Trading Co., Inc. desires to drill said additional well in order to more adequately drain the 160 acre lease described as the SW2 of Section 29, Township 16 South, Range 31 East, N.M.P.M., by drilling a well near the center of said 160 acre tract; and the information received by Texas Trading Co., Inc. is that, due to the tightness of the formation, such additional well would be advantageous in order to obtain a greater production of oil from said lease. That Texas Trading Co., Inc. intends to drill said well to the bottom of the San Andreas Formation found in the area and, in drilling said well, Texas Trading Co., Inc. also desires to drill said well to test methods of completion which were not in use in the industry at the time the original four wells were drilled, such as sandfracting or other methods to increase production.

- 4. For all of the foregoing reasons, Texas Trading Co., Inc. requests the consideration by the Commission of its request for this non-standard location, and requests administrative approval be granted as soon as possible.
- 5. That said well will not be located within the distance from the boundary line of any adjoining lease owner so as to require notice or consent of any adjoining lease owner, inasmuch as Texas Trading Co., Inc. is the owner of the entire lease interest under the said SW2 of Section 29, Township 16 South, Range 31 East, N.M.P.M.
- 6. That the owners of the oil and gas leases offsetting said 100 acres are as follows:

Carper Drilling Company, Artesia, New Mexico, is the owner of the lease lying to the north and to the east, of the 160 acres involved.

Texas Trading Co., Inc., applicant herein, is the owner of a State Oil and Gas Lease lying immediately south of the 160 acres involved.

John Fidel, of Albuquerque, New Mexico, is the owner of lease to the west of the 160 acres involved.

THE APPLICATION OF TEXAS TRADING COMPANY, INC., FOR APPROVAL OF THE DRILLING OF ITS GRIER WALL NO. 5 AS A "FIVE-SPOT" LOCATION WITHIN THE BOUNDARIES OF THE SQUARE LAKE OIL POOL AS AN EXCEPTION TO RULE 104 OF THE RULES AND REQULATIONS OF THE COMMISSION; SAID LOCATION TO BE AT A SITE 1412 FEET FROM THE SOUTH AND WEST LINES OF SECTION 19, TOWNSHIP 16 SOUTH, RANGE SI EAST, NMPM, EDST COUNTY, NEW MEXICO.

#### ORDER OF THE COMMESION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 18, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinefter referred to as the "Commission".

NOW, on this 13th day of June, 1955, the Commission, a quorum being present, having considered the record and the testimony address at said bearing, and being fully advised in the premises,

#### FINDS:

- (1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That petitioner is the owner of a Federal oil and gas lease covering the SW/4 of Section 29. Township 16 South, Range 31 East, NMPM, Eddy County, New Mexico, which lease is known as the Texas Trading Company Grier Lease.
- (3) That there are four producing oil wells at standard locations on aforesaid lease, which wells are producing from the Grayburg and/or upper San Andres formations of the Square Lake Oil Pool.
- (4) That the four existing wells on aforesaid lease are not sufficient to recover all the recoverable oil under this tract, and that the drilling of the "five-spot" location as proposed in applicant's petition would be in the interests of conservation, would prevent waste and would enable applicant to recover substantial quantities of oil which would otherwise not be produced.
- (5) That adjacent leasehold interests have not objected to the drilling of such additional location, and will not be adversely affected by the provisions of this order.

#### IT IS THEREFORE ORDERED:

- (1) That the application of Texas Trading Company, Inc., be and the same hereby is approved, and that applicant is hereby granted permission to drill an unorthodox "five-spet" location at a site 1412 feet from the South and West lines of Section 29, Township 16 South, Range 31 East, NMPM, Eddy County, New Mexico in the Square Lake Pool.
- (2) That applicant shall not receive additional allowable by virtue of the drilling of said "five-spot" location, and that applicant shall produce only that allowable granted the 40-acre unit described as the NE/4 SW/4 of said Section 27 as ordered by the Commission under the previsions of Commission Rule 505.
