MR. PORTER: We will take up next Case 1640.

MR. PAYNE: Case 1640, "Northwestern New Mexico nomenclature case calling for an order changing the designation of a pool and extending existing pools in San Juan and Rio Arriba Counties, New Mexico."

A. R. KENDRICK

called as a witness, having first been duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. PAYNE:

Q Will the witness please state his name and position?

A A. R. Kendrick, engineer for the Oil Commission.

Q Are you the same A. R. Kendrick who was sworn and testified in the case just presented?

A Yes, sir.

Q Mr. Kendrick, in your official capacity with the Oil Conservation Commission, have you had an opportunity to make a study concerning the necessity and desirability for changing the designation or extending certain existing pools in San Juan and

Rio Arriba Counties, New Mexico?

A Yes, sir.

Q What are your recommendations concerning the changing of the designation of the Otero-Graneros Dakota Pool?

A In conjunction with Order R-1287, which is a Dakota spacing order that set up the Dakota producing interval in the San Juan Basin, I recommend that this pool name be changed to the Otero-Dakota Pool.

Q What are your recommendations concerning the extension of the Tapacito-Pictured Cliffs Pool?

A I recommend that the pool be extended as shown on Exhibit One, Paragraph B, on the basis of one well capable of producing from this pool.

Q What are your recommendations concerning the extension of the Blanco-Mesaverde Pool?

A I recommend that the Blanco-Mesaverde Pool be extended as shown in Paragraph F of Exhibit One on the basis of one well capable of producing from that pool.

Q What are your recommendations concerning the extension of the Angels Peak-Gallup Oil Pool?

A I recommend that the Angels Peak-Gallup Oil Pool be extended as shown on Paragraph D of Exhibit One on the basis of two wells capable of producing from that pool.

Q What are your recommendations concerning the extension of the Bisti-Lower Gallup Oil Pool?

A I recommend that the Bisti-Lower Gallup Oil Pool be extended as shown on Paragraph E of Exhibit One on the basis of two wells capable of producing.

Q What are your recommendations concerning the extension of the Horseshoe-Gallup Oil Pool?

A I recommend that the Horseshoe-Gallup Oil Pool be extended as shown on Paragraph F of Exhibit One on the basis of six wells capable of producing from that pool.

Q What are your recommendations concerning the extension of the Verde-Gallup Oil Pool?

A I recommend that the Verde-Gallup Oil Pool be extended as shown on Paragraph G of Exhibit One on the basis of three wells capable of producing.

Q What are your recommendations concerning the extension of the Angels Peak-Dakota Pool?

A I recommend that the Angels Peak-Dakota Pool be extended as shown on Paragraph H of Exhibit One on the basis of four wells capable of producing.

MR. PORTER: The witness may be excused.



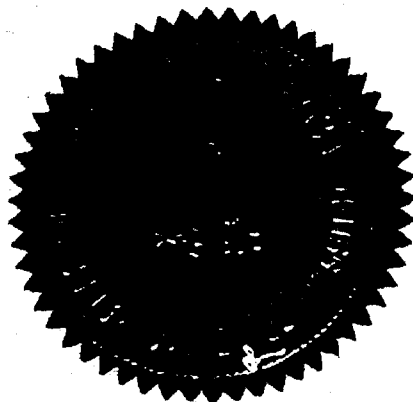
