ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 c'clock a.m. on March 14, 1962 at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW: on this 19th day of Merch, 1962, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Otero-Chacra Pool in Rio Arriba County, New Mexico, to the Table Mesa-Dakota Oil Pool in San Juan County, New Mexico, and to the South Blance-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico.

Applicant, in the above-styled cause, seeks an order establishing special rules and regulations for the Lusk-Strawn Pool, Lea County, New Mexico, including a provision for 160-acre oil proration units.
