THE APPLICATION OF THE OIL CONSERVATION CONMISSION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING CERTAIN FOOLS IN RIO ARRIBA AND SAN JUAN COUNTINS, NEW MEXICO.

CRASS OF THE CONCUSSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 16, 1962, at Hobbs, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 23rd day of May, 1962, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises.

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the proposed creation of a new pool in Section 10, Township 23 North, Range 7 West, Rio Arriba County, New Mexico, for the production of oil from the Gallup formation should be dismissed pending further study.
- (3) That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of oil from the Gallup formation, said pool to bear the designation Mesa-Gallup Oil Pool. Said Mesa-Gallup Oil Pool was discovered by Exploration Drilling Company, Navajo #3, located in the SW/4, Unit N, of Section 24, Township 32 North, Range 18 West, NMPM. It was completed August 15, 1961. Top of perforations is 1110 feet.

(4) That there is need for certain extensions to the Tapacite Pictured Cliffs Pool and to the Puerto Chiquito-Gallup Oil Pool in Rio Arriba County, New Mexico.



ALLOWABLE:

- (1) Consideration of the oil allowable for June, 1962.
- (2) Consideration of the allowable production of gas for June, 1962, for ten prorated pools in Lea and Eddy Counties, New Mexico, and also presentation of purchaser's nominations for said pools for the six-month period beginning July, 1962; consideration of the allowable production of gas for nine prorated pools in San Juan, Rio Arriba and Sandoval Counties, New Mexico, for June, 1962.
- CASE 2558: Application of the Oil Conservation Commission, on its own motion and at the request of El Paso Natural Gas Company, to amend Rule 314.

It is proposed to amend Rule 314 by the addition of paragraph (i) thereto to further regulate the transportation of drip and to require the reporting of such transportation on Form C-110-A.

CASE 2559: Application of Gulf Oil Corporation for an amendment of Rule 112-A. Applicant, in the above-styled cause, seeks an amendment of Rule 112-A to delete that portion of said rule which requires that offset operators be notified of the taking of packer-leakage tests. Applicant further proposes that said rule be amended to provide for notification to an offset operator of the taking of such a test where the offset operator has previously requested that such notification

be given.

- CASE 2560: In the matter of the hearing called on the motion of the 011 Conservation Commission to consider the revision of Rules 201 and 1105 to eliminate the requirement that offset operators be notified prior to the commencement of well plugging operations.
- CASE 2561: In the matter of the hearing called on the motion of the Oil Conservation Commission to consider revising Rule 111, Deviation Tests and Whipstocking. Applicant, in the above-styled cause, seeks an order revising Rule 111 to read in its entirety as follows:

RULE 111. DEVIATION TESTS AND WHIPSTOCKING

- (a) Any well which is drilled or deepened with rotary tools shall be tested at reasonably frequent intervals to determine the deviation from the vertical and a tabulation thereof filed with Form C-105, Well Record. When such deviation averages more than five degrees in any 500-foot interval, no oil or gas shall be sold until it has been established that the bottom of the hole is on the proration unit assigned to the well by means of a deviational and directional survey. In lieu of said survey, the operator may, with specific approval of the Commission, establish the location of the bottom of the hole by filing a notarized tabulation of all deviation tests, assuming the deviation from the vertical and the drift to be in a constant and continuous direction to the nearest boundary of the proration unit.
- (b) No well shall be whipstocked and directionally drilled without special permission from the Commission. Permission to whipstock to straighten a crooked hole, to sidetrack junk in the hole, or to control a blow-out may be obtained from the appropriate District Office of the Commission on Commission Form C-102 with copies of said Form C-102 being furnished all offset operators. Permission to whipstock for any other reason will be granted only after notice and hearing. Upon completion of any whipstocked well and prior to producing any oil or gas therefrom, a deviational and directional survey shall be conducted and a report thereof filed with the Commission.



Q Are you prepared today to recommend to the Commission certain new pools being created and existing pools being extended in Rio Arriba and San Juan Counties, New Mexico?

A Yes.

Q And have you prepared an exhibit which refreshes your recollection?

A Yes.

Q And how have you designated that exhibit?

(Exhibit No. 1 marked for identification)

A Exhibit 1, Case No. 2563.

Q You are referring to Paragraph (a) of that Exhibit No. 1.
What is your recommendation for the creation of a new pool for Gallup production?

A That a new pool be created, designated as the Lybrook-Gallup Oil Pool based on the discovery well in Section 10, Town-ship 23 North, Range 7 West, NMPM. The initial potential is 47 barrels per day. Completed November 11, 1956. Top perforation at 5597 feet. Vertical limits of the pool to be the Gallup formation.

Q Are the horizontal limits of the pool to be as described in Paragraph (a) of Exhibit No. 1?

A Yes.

Q Mr. Kendrick, I note quite a bit of acreage is being taken into this new oil pool. Would you offer any enlightenment

on that point?

- A Recently the further development has proceeded in the area and there are now ten wells in that area.
- Q Where is that pool with respect to the Puerto Chiquito-Gallup oil pool? Is it in the same general area?
 - A No.
- Q Referring to Paragraph (b) of your exhibit, what is your recommendation concerning the creation of a new pool for Gallup production?
- A That a new pool be designated as Mesa-Gallup Oil Pool based on the discovery well, drilled by Exploration Drilling Company, Section 24, Township 32 North, Range 18 West, NMPM. The initial potential is 49 barrels per day. Completed August 15, 1961. Top perforation 1110 feet. Vertical limits being the Gallup formation. Horizontal limits described in Paragraph (b) on the docket of this case and on Exhibit 1.
 - Q How many wells do we have in that pool now?
 - A Ten wells.
- Q And this is the Gallup pool, is that somewhere near Puerto Chiquito-Gallup?
- A No, it is immediately northwest of the Horseshoe-Gallup Oil Pool.
- Q Referring to Paragraph (c) of your exhibit, what is your recommendation concerning the extension of the Tapacite-Pictured Cliffs Pools?

That is to be extended as shown in Paragraph (c) of this Α case based on two wells completed in that area.

What is your recommendation concerning extension of the Puerto Chiquito-Gallup oil pool?

That the pool be extended as shown in Paragraph (d) of this exhibit.

Anything further you would like to add, Mr. Kendrick?

A No.

MR. MORRIS: I offer Exhibit No. 1 in Case 2563 and that concludes the direct examination.

MR. PORTER: The exhibit may be admitted to the record.

(Whereupon Exhibit No. 1 admitted in evidence.)

MR. PORTER: Any questions of Mr. Kendrick? (No response.)

Nothing further to be offered in this case, we will take it under advisement.
