Yes.

Are your recommendations prepared in the form Ç. of an exhibit?

Yes, they are prepared in the form of OCD Exhibit One, Case Number 6354.

Does this exhibit include the creation of any new pools?

Yes, it does. It calls for the creation of two new pools, the first being the Ross Draw Bone Springs Gas Pool, comprising the southwest guarter of Section 27, Township 26 South, Range 30 East, Eddy County, New Mexico. The pool was discovered by the D. B. Baxter Ross Draw Unit, Well No. 5, located in Unit "K" of Section 27. It was completed March 25th, 1978, and the top of the open hole interval is at 8235 feet.

It also calls for the creation of a new gas pool for Atoka production, being the South Sand Ranch Atoka Gas Pool, comprising the east half of Section 17, Township 11 South, Range 30 East, Chaves County. The pool was discovered by the Depco's Beall, B-E-A-L-L Federal Well No. 1, located in Unit "G" of Section 17. It was completed May 22nd, 1977, in the Atoka. The top of the perforations is at 9096 feet.

THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING, EXTENDING VERTICAL LIMITS AND REDESIGNATING POOL, AND EXTENDING HORIZONTAL LIMITS OF CERTAIN POOLS IN CHAVES, EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9:00 a.m. on October 11, 1978, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this 20th day of October, 1978, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new gas pool in Eddy County, New Mexico, for the production of gas from the Bone Springs formation, said pool to bear the designation of Ross Draw-Bone Springs Gas Pool. Said Ross Draw-Bone Springs Gas Pool was discovered by the D. B. Baxter Ross Draw Unit Well No. 5 located in Unit K of Section 27, Township 26 South, Range 30 East, NMPM. It was completed March 25, 1978, in the Bone Springs formation. The top of the perforations is at 8,235 feet.
- (3) That there is need for the creation of a new gas pool in Chaves County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of

South Sand Ranch-Atoka Gas Pool. Said South Sand Ranch-Atoka Gas Pool was discovered by the Depco, Inc. Beall Federal Well No. 1 located in Unit G of Section 17, Town-ship 11 South, Range 30 East, NMPM. It was completed May 22, 1977, in the Atoka formation. The top of the perforations is at 9,096 feet.

- (4) That there is need for the extension of the vertical limits of the Comanche Stateline-Yates Pool in Lea County, New Mexico, to include the Tansill formation and the redesignation of said Comanche Stateline-Yates Pool as the Comanche Stateline-Tansill-Yates Pool. The extension is necessary because of the completion of a well in same pool acreage in both the Tansill and Yates formations.
