Thank you for your transmittal of November 8, 2022. We are providing three matrices in response to your inquiry regarding the calculation of updated costs to reflect development of Unit IIA:

- Attachment II.4.D - Closure/Post-closure Cost Estimates: provided for reference regarding Landfill Closure Construction Cost Estimates (directly from the approved 1/24/20 Permit)
- Table II.5 (new) - Closure Construction Cost Calculations: shows the \$/acre final cover costs approved for Unit I; and then applied pro rata to the new 8.4-acre "Unit IIA" - 8.4-acres x \$19,511/acre = \$163,892. This value includes the 10% mark-up for Management/Administration.

Table II.6 - September 2022 Financial Assurance Update: The first column is derived from the C/PC Cost Summary in the 1/24/20 approved Permit, and the second shows the calculated increase in closure construction costs for Unit IIA. Please note that the Landfill Closure Construction is the only task associated with the Financial Assurance adjustment. Also, note that the post-closure tasks are all calculated for the entire 100-acres± landfill footprint, plus the pond and processing area Post-closure Maintenance. We had considered submitting an incremental strategy for post-closure that would have reduced the costs for these tasks. Instead, Lea Land has been funding FA for post-closure care and monitoring for the entire Facility in order to be conservative.

Lea Land, LLC has adhered to all of the compliance standards necessary before initiating operations in Unit IIA. We have informed OCD of our intent to open the new cell (Unit IIA), which was activated on November 10, 2022. In anticipation of this progress, Lea Land obtained a Rider to our existing FA mechanism with an additional \$163,891 for a total of \$1,549,563. As indicated in Lea Land's 09/09/2022 transmittal to you, we have had a complete set of sealed originals available and have been awaiting your instructions on your preferred address and delivery mode. As you recall, the original FA package in 2019 was misplaced.

In summary, we are confident in our base numbers and the very conventional pro rata \$/acre calculation for final cover construction for Unit IIA. Lea Land, LLC secured Financial Assurance in advance of OCD concurrence to allow for timely opening of Unit IIA, while maintaining full compliance with the Permit Conditions.
