### PURCHASE AND SALE AGREEMENT

This Purchase and Sale Agreement ("<u>Agreement</u>") is made and entered into as of November 16, 2020 (the "<u>Execution Date</u>"), by and between Legacy Reserves Operating LP, a Delaware limited partnership ("<u>Seller</u>") and SBI II, LLC, a Texas limited liability company ("<u>Buyer</u>", and together with Seller collectively, the "<u>Parties</u>" or each a "<u>Party</u>").

## **RECITALS**

WHEREAS, Seller is willing to sell, transfer, convey, and assign to Buyer, and Buyer is willing to purchase, accept, and pay for, the Assets (as defined below), all upon the terms and conditions set forth in this Agreement;


NOW, THEREFORE, in consideration of the mutual benefits derived and to be derived from this Agreement by each Party, Seller and Buyer agree as follows:

- 1. <u>Purchase and Sale</u>. Upon the terms and subject to the conditions of this Agreement, Seller agrees to sell, transfer, convey, and assign the Assets to Buyer and Buyer agrees to purchase, accept, and pay for the Assets.
- 2. <u>Assets</u>. As used herein, the term "<u>Assets</u>" refers to all of Seller's right, title and interest in and to the following, excluding, however, the Excluded Assets:
- (a) all of the oil and gas leases; oil, gas and/or mineral leases; subleases and other leaseholds and leasehold estates created thereby; non-working interests (including any royalty, overriding royalty, net profits interest, volumetric production payment, or other such interest, in all cases other than the Reserved Royalty Interests); carried interests; revisionary rights; operating rights; and other rights, properties and interests described on <u>Exhibit A-1</u> (the "<u>Full Leases</u>") as the same may have been ratified, extended or amended, and all rights, property and interests incident thereto, together with the lands covered thereby or pooled (or unitized) therewith including those lands described for the applicable Full Leases on <u>Exhibit A-1</u> (the "<u>Full Lease</u> <u>Lands</u>", and together with the Full Leases, the "<u>Full Interests</u>");
- other leaseholds and leasehold estates created thereby; non-working interests (including any royalty, overriding royalty, net profits interest, volumetric production payment, or other such interest, in all cases other than the Reserved Royalty Interests); carried interests; revisionary rights; operating rights; and other rights, properties and interests described on <a href="Exhibit A-2">Exhibit A-2</a> (the "Depth Limited Leases") as the same may have been ratified, extended or amended, and all rights, property and interests incident thereto, together with the lands covered thereby or pooled (or unitized) therewith including those lands described for the applicable Depth Limited Leases on <a href="Exhibit A-2">Exhibit A-2</a> (the "Depth Limited Lease Lands"), in each case, INSOFAR AND ONLY INSOFAR as such right, title and interest in and to said Depth Limited Leases and Depth Limited Lease Lands is necessary to produce, sell, and/or market Hydrocarbons from the depths set forth for such Depth Limited Lease on <a href="Exhibit A-2">Exhibit A-2</a> under the Depth Limited Lands covered thereby (the "Depth Limited Interests");

- all of the oil and gas leases; oil, gas and/or mineral leases; subleases and (c) other leaseholds and leasehold estates created thereby; non-working interests (including any royalty, overriding royalty, net profits interest, volumetric production payment, or other such interest, in all cases other than the Reserved Royalty Interests); carried interests; revisionary rights; operating rights; and other rights, properties and interests described on Exhibit A-3 (the "Wellbore" Limited Leases"), and the lands described for the applicable Wellbore Limited Lease or pooled (or unitized) therewith including those lands described for the applicable Wellbore Limited Leases on Exhibit A-3 (the "Wellbore Limited Lease Lands"), in each case, INSOFAR AND ONLY INSOFAR as such right title and interest in and to said Wellbore Limited Lease and Wellbore Limited Lease Lands is necessary to produce, sell and/or market Hydrocarbons produced from (i) the Specified Wellbores as such Specified Wellbores exist on the Effective Time or as re-drilled in the future and (ii) any facilities in the Wellbore Limited Lease Lands related to the Specified Wellbores, and such right, title and interest described in this Section 2(c) shall include all of Seller's rights of ingress and egress through and across the Wellbore Limited Leases INSOFAR AND ONLY INSOFAR as such right title and interest in and to said rights of ingress and egress is necessary to produce, sell and/or market Hydrocarbons produced from (i) the Specified Wellbores as such Specified Wellbores exist on the Effective Time or as re-drilled in the future and (ii) any facilities in the Wellbore Limited Lease Lands related to the Specified Wellbores (the "Wellbore Only Interests" and together with the Depth Limited Interests and Full Interests, the "Subject Interests");
- (d) any and all Hydrocarbon, water, CO2, or injection or disposal wells to the extent such wells are located on the Full Interests or on lands pooled, communitized, or unitized therewith, including, but not limited to, the interests in the wells shown on **Exhibit B-1**, and all Hydrocarbons, water, and CO2 in, on, under or produced from the Full Lease Lands or allocated thereto from and after the Effective Time, in each case to the extent such interest is derived from the Full Interests and regardless of whether such wells are producing, non-producing, permanently or temporarily plugged and abandoned, and whether or not fully described on any exhibit or schedule hereto (the "Full Wells");
- (e) any and all Hydrocarbon, water, CO2, or injection or disposal wells to the extent located on the Depth Limited Interests or on lands pooled or communitized or unitized therewith, including, but not limited to, the interests in the wells shown on **Exhibit B-2**, and all Hydrocarbons, water, and CO2 in, on, under or produced from the Depth Limited Lease Lands or allocated thereto from and after the Effective Time, in each case to the extent such interest is derived from the Depth Limited Interests and regardless of whether such wells are producing, non-producing, permanently or temporarily plugged and abandoned, and whether or not fully described on any exhibit or schedule hereto (the "Depth Limited Wells");
- **Exhibit B-3**, and all Hydrocarbons, water, and CO2 in, on, under or produced from the Wellbore Limited Lease Lands or allocated thereto from and after the Effective Time, in each case whether producing, non-producing, permanently or temporarily plugged and abandoned (the "<u>Specified Wellbores</u>" and together with the Full Wells and the Depth Limited Wells the "<u>Wells</u>");
- (g) all pooled, communitized, or unitized acreage which includes all or part of any Subject Interest, in each case, to the extent attributable to being pooled, communitized or

unitized with any Subject Interest, and all tenements, hereditaments, and appurtenances belonging thereto (the "*Units*" and, together with the Wells and Subject Interests, the "*Properties*");

- (h) all currently existing contracts, agreements, and instruments pertaining to the Properties and the other Assets described in Sections 2(i) and 2(j) (to the extent and only to the extent applicable to the other Assets) including operating agreements; unitization, pooling, and communitization agreements; declarations and orders; area of mutual interest agreements; farmin and farmout agreements; exchange agreements; purchase and sale agreements and other contracts in which Seller acquired interests in any of the Properties or the other Assets described in Sections 2(i) and 2(j); compressor agreements; gathering agreements; agreements for the sale and purchase of Hydrocarbons; disposal agreements; transportation agreements; and processing agreements (the "Contracts"); provided, however, that the term "Contracts" shall not include the Full Leases, the Depth Limited Leases, the Wellbore Limited Leases;
- (i) all easements, surface permits, surface licenses, servitudes, rights-of-way, surface leases, and other rights to use the surface appurtenant to, and used or held for use solely in connection with, the ownership or operation of the Properties (the "*Rights of Way*");
- (j) all equipment, facilities, machinery, fixtures, and other tangible personal property and improvements that are located on the Properties to the extent that they are used or held for use in connection with the ownership or operation of the Properties or any of the other Assets or the production, treatment, storage, disposal, or transportation of Hydrocarbons or other substances therefrom (including all such wellhead equipment, pumps, pumping units, Hydrocarbon measurement facilities, flowlines, gathering systems, piping, pipelines, compressors, tanks, treatment facilities, injection facilities, disposal facilities, compression facilities, and other materials, supplies, facilities and machinery) (collectively, the "Equipment");
- (k) all Hydrocarbons produced from, or attributable to, the Properties from and after the Effective Time; all Hydrocarbon inventories from or attributable to the Properties that are in storage on the Effective Time; and, to the extent related or attributable to the Properties, all production, plant, and transportation imbalances as of the Effective Time (provided, however, (i) that Buyer's rights to the inventories and imbalances described in this subsection (k) shall be satisfied solely pursuant to Section 14, and (ii) for the avoidance of doubt, the "Assets" shall not include any amounts held in suspense by Seller on behalf of third Persons or accounts payable out of production of Hydrocarbons that are owed to third Persons); and
- (I) all lease files, land files, division order files, abstracts, title opinions, contract files, geological or geophysical data and well and production records of Seller, to the extent relating to the Properties, but excluding, in each case:
- (i) all corporate, financial, tax, and legal data and records of Seller that relate to Seller's business generally (whether or not relating to the Assets) or to Seller's business, operations, assets, and properties not expressly included in this Agreement;



- 17. <u>Disclaimers</u>. Other than the express representations contained in <u>Section 11</u> of this Agreement and the special warranty of Defensible Title contained in the Conveyance, <u>SELLER MAKES NO OTHER EXPRESS OR IMPLIED WARRANTIES OR REPRESENTATIONS AS TO AS TO THE ASSETS WHATSOEVER, INCLUDING, AS TO THE QUALITY, <u>MERCHANTABILITY</u>, <u>OR FITNESS OF THE ASSETS FOR BUYER'S INTENDED USE OR FOR ANY USE WHATSOEVER, AND BUYER ACCEPTS THE ASSETS "AS IS"</u>, "WHERE IS", "WITH ALL FAULTS", IN THEIR PRESENT CONDITION AND STATE OF REPAIR.</u>
- 18. Assumed Obligations. From and after Closing, Buyer shall assume and hereby agrees to fulfill, perform, pay and discharge (or cause to be fulfilled, performed, paid and discharged) all obligations and Liabilities (defined below), whether known or unknown, liquidated or contingent, to the extent arising from, based upon, related to, or associated with, the Assets, regardless of whether such obligations or Liabilities arose prior to, on, or after the Effective Time (all such obligations and Liabilities, the "Assumed Obligations").

## 19. **Indemnification**.

(a) <u>Indemnification by Seller</u>. Effective from and after the Closing, subject to the limitations set forth this <u>Section 19</u> and otherwise in this Agreement, Seller and its successors and assigns shall be responsible for, shall pay, and will DEFEND, INDEMNIFY and HOLD HARMLESS Buyer and its Affiliates, and all of its and their respective equity holders, partners, members, directors, officers, managers, employees, agents and representatives (collectively, the "<u>Buyer Indemnified Parties</u>") from and against any and all claims, causes of actions, payments, charges, interest assessments, judgments, liabilities, losses, damages, penalties, fines or costs and expenses, including any reasonable fees of attorneys, experts, consultants, accountants and other
