ORDER NO. AG-37-A

GAS PRORATION ORDER FOR JULY 1, 1972  
THROUGH DECEMBER 31, 1972

This cause came on for public hearing by the Commission's examiner, R. L. Stamets, at Santa Fe, New Mexico, on May 17, 1972, at 9 a.m., pursuant to legal notice for the purpose of setting the allowable production of gas from the following fifteen gas pools in Lea, Eddy, Chaves, and Roosevelt Counties, New Mexico, for the period, July 1, 1972, through December 31, 1972.

Atoka-Pennsylvanian, Bagley-Lower Pennsylvanian, Bagley-Upper Pennsylvanian, Blinebry, Bluitt-San Andres Associated, Buffalo Valley-Pennsylvanian, Crosby-Devonian, Eumont, Indian Basin-Morrow, Indian Basin-Upper Pennsylvanian, Jalmat, Justis, Monument McKee-Ellenburger, Todd-Lower San Andres Associated, and Tubb.

NOW, on this 19th day of May, 1972, the Commission, a quorum being present, having considered the nominations of purchasers, the capacity of producing wells, and the recommendations of the Examiner, and being otherwise fully advised in the premises,

FINDS:

(1) That the total nomination of purchasers of gas produced from the above-listed fifteen gas pools for the period, July 1, 1972, through December 31, 1972, is 108,406,744 Mcf. The individual pool nominations are as follows:

(2) That the potential producing capacity of all gas wells in the fifteen gas pools listed above is in excess of the nominations of purchasers of gas, and in order to prevent waste and protect correlative rights, the production of gas from the above-listed fifteen gas pools should be limited, allocated, and distributed during the proration period commencing July 1, 1972.

(3) That all the producing gas wells, together with the expected completed or recompleted wells in the fifteen gas pools listed above, can produce a total of 108,406,744 Mcf without causing waste within the proration period commencing July 1, 1972, and an allocation based upon such production would be reasonable and would protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That for the proration period commencing July 1, 1972, the total allowable production to be assigned the fifteen allocated gas pools in Lea, Eddy, Chaves, and Roosevelt Counties, New Mexico, is as follows:

(2) That the allocation hereby set for said proration period in the fifteen allocated pools in Lea, Eddy, Chaves, and Roosevelt Counties, New Mexico, shall be in accordance with the Commission Rules, Regulations, and Orders.

(3) That the total allowable production for each pool as set forth shall be allocated on a monthly basis and shall be adjusted monthly to meet changes in market conditions as reflected by purchasers' supplemental nominations and actual gas production, in accordance with the Commission Rules, Regulations, and Orders.


The foregoing order shall remain effective until further order of the Commission.
