ORDER NO. AG-CD

GAS PRORATION ORDER FOR PERIOD APRIL 1, 1957
THROUGH DECEMBER 31, 1957

The Commission held public hearing at Santa Fe, New Mexico, on February 14, 1957, at 9 a.m., pursuant to legal notice for the purpose of setting the allowable production of gas from the Crosby-Devonian Gas Pool in Lea County, New Mexico, for the nine-month period, April 1, 1957, through December 31, 1957.

NOW, on this day the Commission, a quorum being present, having considered the nominations of purchasers, the capacity of producing wells and being otherwise fully advised in the premises,

FINDS:

1. That the total nominations of purchasers of gas produced from the above-listed Crosby-Devonian Gas Pool for the period April 1, 1957, through December 31, 1957, is 4,400,000 MCF.
2. The potential producing capacity of all gas wells in the Crosby-Devonian Gas Pool is in excess of the nominations of purchasers of gas and in order to prevent waste and protect correlative rights, the production of gas from the above-listed gas pool should be limited, allocated and distributed during the nine-month proration period commencing April 1, 1957.
3. That all the producing gas wells together with the expected completed or recompleted wells in the Crosby-Devonian Gas Pool can produce a total of 4,400,000 MCF without causing waste within the nine-month period commencing April 1, 1957, and an allocation based upon such production would be reasonable and protect correlative rights.

IT IS THEREFORE ORDERED:

1. For the nine-month proration period commencing April 1, 1957, the total allowable production to be assigned the Crosby-Devonian Gas Pool in Lea County, be and the same hereby is 4,400,000 MCF.
2. That the allocation hereby set for said nine-month proration period in the Crosby-Devonian Gas Pool in Lea County, New Mexico, shall be in accordance with the provisions of Order R-639-A, and the Commission's Rules and Regulations.
3. The total allowable production for the Crosby-Devonian Gas Pool as set forth shall be allocated on a monthly basis in accordance with Schedule "A" attached hereto and such schedule shall be adjusted monthly to meet changes in market conditions reflected by purchasers' supplemental nominations and

actual gas production in accordance with Order R-639-A.


The foregoing order shall remain effective until further order of the Commission.
