SUPPLEMENTAL GAS PRORATION ORDER FOR THE MONTH OF NOVEMBER, 1975

This cause came on for public hearing by the Commission's Examiner, Daniel S. Nutter, at Santa Fe, New Mexico, on October 15, 1975, at 9 a.m., pursuant to legal notice for the purpose of setting the allowable production of gas from the following five gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, for the month of November, 1975.

Basin-Dakota, Blanco-Mesaverde, Blanco-Pictured Cliffs, South, Tapacito-Pictured Cliffs, and Devils Fork-Gallup.

NOW, on this <u>21st</u> day of October, 1975, the Commission, a quorum being present, having considered the supplemental nominations of purchasers, the capacity of producing wells, and the recommendations of the Examiner, and being otherwise fully advised in the premises,

FINDS:

(1) That the total nomination of purchasers of gas produced from the above-listed five gas pools for the month of November, 1975, is 39,439,900 Mcf. The individual pool nominations are as follows:

Basin-Dakota	14,891,200 Mc	f
Blanco-Mesaverde	20,657,200 Mc	f
Blanco-Pictured Cliffs, South	2,816,600 Mc	f
Tapacito-Pictured Cliffs	1,048,000 Mc	f
Devils Fork-Gallup	26,900 Mc	f

- (2) That the potential producing capacity of all gas wells in the five gas pools listed above is in excess of the nominations of purchasers of gas, and in order to prevent waste and protect correlative rights, the production of gas from the above-listed five gas pools should be limited, allocated, and distributed during the month of November, 1975.
- (3) That all the producing gas wells, together with the expected completed or recompleted wells in the five gas pools listed above, can produce a total of 39,439,900 Mcf without causing waste during the month of November, 1975, and an allocation based upon such production would be reasonable and would protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That for the month of November, 1975, the allowable production to be assigned the five allocated gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, is as follows:

Basin-Dakota	14,891,200 Mcf
Blanco-Mesaverde	20,657,200 Mcf
Blanco-Pictured Cliffs, South	2,816,600 Mcf
Tapacito-Pictured Cliffs	1,048,000 Mcf
Devils Fork-Gallup	26,900 Mcf

- (2) That the allocation hereby set for the month of November, 1975, in the five allocated pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, shall be in accordance with the Commission Rules, Regulations, and Orders.
- (3) That a proration schedule, duly prepared by the Commission and thereafter adopted for the month of November, 1975, is hereto attached and made a part hereof; it distributes and allocates the allowable production among the gas wells in the five gas pools listed above for the period stated, in accordance with the Commission Rules, Regulations, and Orders.

The foregoing order shall remain effective until further order of the Commission.
