THE APPLICATION OF GULF OIL CORPORATION FOR PERMISSION TO DUALLY COMPLETE ITS H. LEONARD 'E' WELL NO. 4, NE/4 NE/4 SECTION 16, TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM, LEA COUNTY, NEW MEXICO.

ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-316, Rule 112-A, Gulf Oil Corporation made application to the New Mexico Oil Conservation Commission on February 15, 1954, for permission to dually complete its H. Leonard 'E' Well No. 4, NE/4 NE/4 Section 16, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, and

The Secretary-Director Finds:

(1) That application has been duly filed under the provisions of Subsection 'c' of Rule 112-A of the Commission's Rules and Regulations;

(2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and

(3) That no objections have been received within the waiting period as prescribed by said rule.

IT IS THEREFORE ORDERED:

That the applicant herein, Gulf Oil Corporation, be and it hereby is authorized to dually complete its H. Leonard 'E' Well No. 4, NE/4 NE/4 Section 16, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, in such manner:

- (a) That the Drinkard formation of the Drinkard Oil Pool, from which the well has previously produced, be properly plugged off for abandonment as contemplated by applicant.
- (b) That gas from the Blinebry zone of the Blinebry Gas Pool may be then produced through the casingtubing annulus, and gas from the Tubb formation of the Tubb Gas Pool through the tubing, by proper perforations and the installation of a suitable packer;

PROVIDED, HOWEVER, That subject well shall be completed and thereafter produced in such a manner that there will be no commingling within the well-bore, either within or outside the casing, of gas, oil and gas, or oil produced from either or both of the separate strata,

PROVIDED, HOWEVER, That prior to the actual dual completion the operator shall make pressure tests of the casing to prove that no casing leaks have developed since the well was originally completed. In the event a casing leak is apparent the operator shall take appropriate steps to adequately repair the leak. The results of these tests shall be reported to the Commission on Form C-103. Page 2 --- DC-72

PROVIDED FURTHER, That upon the actual dual completion of such subject well applicant shall submit to the District Office of the Commission at Hobbs, New Mexico, copies of Oil Conservation Commission Form C-103, Form C-104, Form C-110, and Form C-122 outlining the information required on those forms by existing Rules and Regulations, and two copies of the electric log of the well, if available.

<u>PROVIDED FURTHER</u>. That said subject well for dual completion and production shall be equipped in such a way that reservoir pressures may be determined separately for each of the two specified strata, and further, be equipped with all necessary connections required to permit recording meters to be installed and used, at any time, as may be required by the Commission or its representatives, in order that natural gas, oil, or oil and gas from each separate stratum may be accurately measured and the gas-oil ratio thereof determined, and

PROVIDED FURTHER, That the operator-applicant shall make any and all tests, including segregation tests, but not excluding other tests and/or determinations at any convenient time and in such manner as deemed necessary by the Commission; the original and all subsequent tests shall be witnessed by representatives of the Commission and by representatives of offset operators, if any there be, at their election, and the results of each test properly attested to by the applicant herein and all witnesses, and shall be filed with the Commission within ten days after completion of such test, and

<u>PROVIDED FURTHER</u>, That upon the actual dual completion of such subject well, applicant shall submit to the Commission a diagrammatic sketch of the mechanical installation which was actually used to complete and produce the seal between the strata, and a special report of production, gas-oil ratio and reservoir pressure determination of each producing zone or stratum immediately following completion.

IT IS FURTHER ORDERED, That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after proper notice and hearing, the Commission may terminate the authority hereby granted and require applicant or its successors and assigns to limit its activities to regular singlezone production in the interests of conservation.
