APPLICATION OF OIL CONSERVATION DIVISION FOR AN ORDER AMENDING RULES 1111, 1112 AND 1115 OF ITS GENERAL RULES AND REGULATIONS

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 10, 1994, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission." On February 17, 1994, an interim order, Order No. R-10061, was issued which was effective until new rules 1111, 1112 and 1115 were adopted by the Commission.

NOW, on this 12th day of December, 1996, the Commission, a quorum being present, having considered the record and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) On August 15, 1996, Case No. 11551 captioned "Application of Oil Conservation Division for an Order Amending Rule 1115 of its General Rules and Regulations Pertaining to the Operator's Monthly Report" came on for hearing before the Commission. On October 29, 1996, the Commission issued Order No. R-10691 which amended Rule 1115 to provide, among other changes, that form C-115's "must be postmarked or received electronically no later than the fifteenth (15th) day of the second month following the month of production."

(3) The Division has recommended that interim Order No. R-10061 requiring Gas Transporter's Monthly Reports (C-111) to be postmarked on or before the fifteenth (15th) day of the second month following the month gas was taken and Transporter's and Storer's Monthly Reports (C-112) to be postmarked on or before the fifteenth (15th) day of the second succeeding month be made permanent. This change would comport with the filing date change made to Rule 1115 regarding Operator's (production) Monthly Reports (C-115). The Commission concurs. Therefore New Mexico Oil Conservation Division Rules 1111 and 1112 need to be amended to conform with the new filing deadline established in Rule 1115 by Order No. R-10691.

(4) Division Rules 1111.A and 1112 should be amended in the manner as set forth in Exhibit "A", attached hereto so that the reporting dates for Rules 1111, 1112 and 1115 are the same.

IT IS THEREFORE ORDERED THAT:

(1) Division Rules 1111.A and 1112 are hereby amended, compiled, recodified and adopted as shown on Exhibit A, attached hereto and made part of this order.

(2) Rules 1111.A and 1112 as amended shall be effective as of the date of publication in the New Mexico Register.

(3) Interim Order No. R-10061 shall be made permanent and incorporated into Rules 1111.A and 1112.

(4) Jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.

1111 GAS TRANSPORTER'S MONTHLY REPORT (Form C-111)

1111.A. Form C-111, Gas Transporter's Monthly Report, shall be filed monthly in accordance with the rules below. It shall be postmarked on or before the 15th day of the second month following the month gas was taken. One copy shall be filed with the appropriate District Office of the Division and one copy with the Santa Fe Office of the Division. One additional copy shall also be sent to the Hobbs Office of the Division. Information on Sheet No. 2 of Form C-111 shall be itemized by pools, by operators, and by leases, in alphabetical order. [1-1-65... - -96]

1112 TRANSPORTER'S AND STORER'S MONTHLY REPORT (Form C-112)

Each transporter and each storer of crude petroleum oil and liquid hydrocarbons within the State of New Mexico shall file for each calendar month a Transporter's and Storer's Monthly Report, Form C-112, containing complete information and data indicated by such form respecting stocks of crude petroleum oil and liquid hydrocarbons on hand and receipts and deliveries of crude petroleum oil and liquid hydrocarbons by pipeline and trucks within the State of New Mexico, and receipts and deliveries from leases to storers or refiners: between transporters within the State: between storers and refiners within the State. Form C-112 shall be filed in DUPLICATE and postmarked on or before the 15th day of the second succeeding month. [1-1-65... - 96]
