## ORDER OF THE COMMISSION

## BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on July 24, 1957, at Santa Fe, New Mexico, before Daniel S. Nutter, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this  $2^{\frac{t}{2}}$  day of August, 1957, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

## FINDS:

- (1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Horace F. McKay, Jr., proposes to produce the McKay-Payne-Zachry Bearden No. 1 Well, located 1750 feet from the North line and 890 feet from the West line of Section 19, Township 29 North, Range 10 West, NMPM, Aztec Fruitland Pool, San Juan County, New Mexico, through the 4-1/2 inch casing, without setting tubing, due to hazards occasioned by the high pressures presently existing in said well.
- (3) That approval of the subject application will not cause waste nor impair correlative rights.
- (4) That the Commission should require tubing to be set in the said McKay-Payne-Zachry Bearden No. 1 Well when the same can be safely accomplished.

## IT IS THEREFORE ORDERED:

That the applicant, Horace F. McKay, Jr., be and the same is hereby authorized to produce his McKay-Payne-Zachry Bearden No. 1 Well, located 1750 feet from the North line and 890 feet from the West line of Section 19, Township 29 North, Range 10 West, NMPM, Aztec Fruitland Pool, San Juan County, New Mexico, through the 4-1/2 inch casing, without setting tubing until such time as the Commission determines that said well can be tubed without undue hazard.
