COUNTY, NEW MEXICO.

INTERIM ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 17, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 21st day of October, 1957, the Commission, a quorum being present, having considered the application and the evidence adduced and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Commission was unable to hear the above-styled application in its entirety at the time the case was called for hearing.

(3) That in the interests of continuity and clarity of presentation, the subject application should be presented at an uninterrupted hearing.

(4) That it would be possible to conduct such a hearing commencing on October 28, 1957, and that the case should, therefore, be continued until that date.

(5) That the pilot water flood project authorized by Order No. R-972 dated April 5, 1957, in the Caprock-Queen Pool, Lea County, New Mexico, has caused an increase in the producing capacity in certain of the wells in said pilot area to the extent that said wells are now capable of producing in excess of the daily top unit allowable.

(6) That there are eighteen (18) 40-acre proration units involved in the above-referenced pilot water flood project and that the description of said units is as follows:

SW/4 NE/4, NE/4 SW/4, SE/4 SW/4, SW/4 SW/4,

SECTION 5, TOWNSHIP 13 SOUTH, RANGE 32 EAST, NMPM
NW/4 NW/4, NE/4 NW/4, SW/4 NW/4,

SECTION 6, TOWNSHIP 13 SOUTH, RANGE 32 EAST, NMPM
NE/4 NE/4, NW/4 NE/4, SW/4 NE/4, SE/4 NE/4,
NE/4 SE/4, NE/4 NW/4.

(7) That there are twelve (12) wells which are presently producing oil from the Caprock-Queen Pool within the pilot area, to-wit:

(8) That the applicant requests that the eighteen (18) 40-acre proration units involved in the above-referenced pilot water flood project be assigned top unit allowables and that it be permitted to produce said allowables from any of the twelve above-mentioned producing wells.

(9) That all of the parties appearing in the subject case have stipulated to the above request.

IT IS THEREFORE ORDERED:

(1) That Case No. 1324 be continued until 9 o'clock a.m. on October 28, 1957, at Mabry Hall, State Capitol, Santa Fe, New Mexico.

(2) That the Commission proration manager be and the same is hereby authorized to assign each of the following described wells a daily allowable, the sum of which allowables shall not exceed 18 daily normal unit allowables:
