THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

#### ORDER OF THE DIVISION

#### BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on April 3, 1997, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this <u>9th</u> day of April, 1997, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

#### FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of South Chisum-San Andres Pool. Said South Chisum-San Andres Pool was discovered by the Marbob Energy Corporation Katie Elder State Well No. 1 located in Unit J of Section 36, Township 11 South, Range 27 East, NMPM. It was completed in the San Andres formation on November 20, 1996. The top of the perforations is at 2,664 feet.
- (3) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of South Corral Canyon-Delaware Pool. Said South Corral Canyon-Delaware Pool was

discovered by the Yates Drilling Company Bennett Federal Well No. 1 located in Unit O of Section 30, Township 25 South, Range 30 East, NMPM. It was completed in the Delaware formation on September 18, 1983. The top of the perforations is at 3,514 feet.

- (4) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Premier formation, said pool to bear the designation of High Lonesome-Premier Pool. Said High Lonesome-Premier Pool was discovered by the McClellan Oil Corporation Hinkle Federal Well No. 5 located in Unit L of Section 10, Township 16 South, Range 29 East, NMPM. It was completed in the Premier formation on April 12, 1985. The top of the perforations is at 2,350 feet.
- (5) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of Lone Wolf-San Andres Pool. Said Lone Wolf-San Andres Pool was discovered by the McClellan Oil Corporation Stevens Federal Well No. 4 located in Unit P of Section 27, Township 13 South, Range 29 East, NMPM. It was completed in the San Andres formation on November 13, 1981. The top of the perforations is at 2,766 feet.
- (6) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of West Lost Tank-Delaware Pool. Said West Lost Tank-Delaware Pool was discovered by the Pogo Producing Company Lost Tank "4" Federal Well No. 1 located in Unit C of Section 4, Township 22 South, Range 31 East, NMPM. It was completed in the Delaware formation on October 12, 1996. The top of the perforations is at 7,772 feet.
- (7) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of East Scanlon-Delaware Pool. Said East Scanlon-Delaware Pool was discovered by the Yates Petroleum Corporation Zinnia Federal Unit Well No. 1 located in Unit E of Section 27, Township 20 South, Range 29 East, NMPM. It was completed in the Delaware formation on June 18, 1996. The top of the perforations is at 3,900 feet.
- (8) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Strawn formation, said pool to bear the designation of Turkey Track-Strawn Gas Pool. Said Turkey Track-Strawn Gas Pool was discovered by the Threshold Development Company Conoco "9A" State Well No. 1 located in Unit G of Section 9, Township 19 South, Range 29 East, NMPM. It was completed in the Strawn formation on December 20, 1996. The top of the perforations is at 10,314 feet.
- (9) There is need for certain extensions to the Alacran Hills-Wolfcamp Gas Pool, the Angell Ranch-Atoka-Morrow Gas Pool, the Antelope Sink-Upper Pennsylvanian Gas

Pool, the Atoka-Glorieta-Yeso Pool, the East Brushy Draw-Delaware Pool, the North Burton Flat-Wolfcamp Gas Pool, the South Carlsbad-Morrow Gas Pool, the Cass Draw-Delaware Pool, the Cedar Canyon-Bone Spring Pool, the Cedar Canyon-Delaware Pool, the Cemetery-Strawn Gas Pool, the Cottonwood Creek-Wolfcamp Gas Pool, the North Dagger Draw-Upper Pennsylvanian Pool, the South Dagger Draw-Upper Pennsylvanian Associated Pool, the West Dagger Draw-Wolfcamp Gas Pool, the Empire-Strawn Gas Pool, the Fren-Paddock Pool, the Grayburg Jackson-Seven Rivers-Queen-Grayburg-San Andres Pool, the Happy Valley-Delaware Pool, the West Henshaw-Grayburg Pool, the Hoag Tank-Strawn Gas Pool, the Hoag Tank-Wolfcamp Gas Pool, the Indian Loafer Draw-Upper Pennsylvanian Gas Pool, the Ingle Wells-Delaware Pool, the Northeast Livingston Ridge-Atoka Gas Pool, the Logan Draw-Morrow Gas Pool, the East Millman-Queen-Grayburg-San Andres Pool, the East Pierce Crossing-Bone Spring Pool, the South Poker Lake-Delaware Pool, the Saladar-Upper Pennsylvanian Gas Pool, the Sand Tank-Morrow Gas Pool, and the Willow Lake-Delaware Pool, all in Eddy County, New Mexico, and the Lake Arthur-Pennsylvanian Gas Pool in Chaves County, New Mexico.

#### IT IS FURTHER ORDERED THAT:

- (1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations and extensions included herein shall be May 1, 1997.
