THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING, CONTRACTING, AND EXTENDING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

<u>BY THE DIVISION</u>:

This cause came on for hearing at 8:15 a.m. on July 10, 1997, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this <u>16th</u> day of July, 1997, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Upper Pennsylvanian formation, said pool to bear the designation of South Carlsbad-Upper Pennsylvanian Gas Pool. Said South Carlsbad-Upper Pennsylvanian Gas Pool was discovered by the Mobil Producing Texas & New Mexico Inc. Federal LL Well No. 1 located in Unit O of Section 13, Township 23 South, Range 26 East, NMPM. It was completed in the Upper Pennsylvanian formation on January 27, 1982. The top of the perforations is at 9,954 feet.

(3) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of

West Catclaw Draw-Morrow Gas Pool. Said West Catclaw Draw-Morrow Gas Pool was discovered by the Marbob Energy Corporation Como Fee Well No. 1 located in Unit F of Section 17, Township 21 South, Range 25 East, NMPM. It was completed in the Morrow formation on May 2, 1997. The top of the perforations is at 10,259 feet.

(4) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Mississippian formation, said pool to bear the designation of Chisum-Mississippian Gas Pool. Said Chisum-Mississippian Gas Pool was discovered by the Plains Radio Petroleum Corporation Plains "16" State Well No. 1 located in Unit B of Section 16, Township 11 South, Range 28 East, NMPM. It was completed in the Mississippian formation on February 27, 1989. The top of the perforations is at 6,816 feet.

(5) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Strawn formation, said pool to bear the designation of Cottonwood Creek-Strawn Gas Pool. Said Cottonwood Creek-Strawn Gas Pool was discovered by the Yates Petroleum Corporation Cottonwood "KI" Federal Com. Well No. 1 located in Unit J of Section 17, Township 16 South, Range 25 East, NMPM. It was completed in the Strawn formation on August 8, 1979. The top of the perforations is at 6,868 feet.

(6) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Fren-Morrow Gas Pool. Said Fren-Morrow Gas Pool was discovered by the Texaco Exploration and Production, Inc. Skelly Unit Well No. 902 located in Unit E of Section 15, Township 17 South, Range 31 East, NMPM. It was completed in the Morrow formation on April 6, 1997. The top of the perforations is at 11,980 feet.

(7) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation of Gatuna Canyon-Bone Spring Pool. Said Gatuna Canyon-Bone Spring Pool was discovered by the Hanley Petroleum Inc. Adams Federal Well No. 1 located in Unit N of Section 31, Township 19 South, Range 31 East, NMPM. It was completed in the Bone Spring formation on April 30, 1997. The top of the perforations is at 7,986 feet.

(8) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of Southeast La Huerta-Atoka Gas Pool. Said Southeast La Huerta-Atoka Gas Pool was discovered by the Cities Service Company Government "AD" Well No. 2 located in Unit E of Section 27, Township 21 South, Range 27 East, NMPM. It was completed in the Atoka formation on November 2, 1978. The top of the perforations is at 10,613 feet.

(9) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Strawn formation, said pool to bear the designation of Little Box Canyon-Strawn Gas Pool. Said Little Box Canyon-Strawn Gas Pool was discovered by the Yates Petroleum Corporation Federal "HQ" Well No. 1 located in Unit N of Section 5, Township 21 South, Range 22 East, NMPM. It was completed in the Strawn formation on July 22, 1988. The top of the perforations is at 7,538 feet.

(10) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of East McKittrick Hills-Atoka Gas Pool. Said East McKittrick Hills-Atoka Gas Pool was discovered by the Mitchell Energy Corporation McKittrick "30" Federal Well No. 1 located in Unit C of Section 30, Township 22 South, Range 26 East, NMPM. It was completed in the Atoka formation on November 29, 1994. The top of the perforations is at 11,540 feet.

(11) Thee is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Wolfcamp formation, said pool to bear the designation of North Parkway-Wolfcamp Pool. Said North Parkway-Wolfcamp Pool was discovered by the Southland Royalty Company Parkway "B" State Well No. 1 located in Unit I of Section 15, Township 19 South, Range 29 East, NMPM. It was completed in the Wolfcamp formation on September 20, 1980. The top of the perforations is at 9,044 feet.

(12) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation of South Pierce Crossing-Bone Spring Pool. Said South Pierce Crossing-Bone Spring Pool was discovered by the Nearburg Producing Company Ruby "30" State Com. Well No. 1 located in Unit O of Section 30, Township 24 South, Range 29 East, NMPM. It was completed in the Bone Spring formation on January 17, 1997. The top of the perforations is at 8,866 feet.

(13) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Upper Pennsylvanian formation, said pool to bear the designation of Rock Tank-Upper Pennsylvanian Gas Pool. Said Rock Tank-Upper Pennsylvanian Gas Pool was discovered by the Mineral Technologies, Inc. Dark Canyon Well No. 1 located in Unit D of Section 18, Township 23 South, Range 25 East, NMPM. It was completed in the Upper Pennsylvanian formation on January 28, 1975. The top of the perforations is at 8,510 feet.

(14) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Southeast Rocky Arroyo-Morrow Gas Pool. Said Southeast Rocky Arroyo-Morrow Gas Pool was discovered by the Penwell Energy, Inc. Wagon Wheel "22" Federal Unit Well No.

1 located in Unit O of Section 22, Township 22 South, Range 22 East, NMPM. It was completed in the Morrow formation on March 17, 1997. The top of the perforations is at 7,418 feet.

(15) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of Seven Rivers Hills-Atoka Gas Pool. Said Seven Rivers Hills-Atoka Gas Pool was discovered by the Fasken Oil and Ranch, Ltd. Mobil "10" Federal Well No. 1 located in Unit M of Section 10, Township 21 South, Range 24 East, NMPM. It was completed in the Atoka formation on July 23, 1996. The top of the perforations is at 9,344 feet.

(16) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Upper Pennsylvanian formation, said pool to bear the designation of Sheep Draw-Upper Pennsylvanian Gas Pool. Said Sheep Draw-Upper Pennsylvanian Gas Pool was discovered by the Louis Dreyfuss Natural Gas Corporation Squaw Federal Well No. 3 located in Unit K of Section 1, Township 23 South, Range 25 East, NMPM. It was completed in the Upper Pennsylvanian formation on November 14, 1985. The top of the perforations is at 9,754 feet.

(17) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of North Shugart-Delaware Pool. Said North Shugart-Delaware Pool was discovered by the Harvey E. Yates Company Can-Ken "4" Federal Well No. 2 located in Unit G of Section 4, Township 18 South, Range 31 East, NMPM. It was completed in the Delaware formation on March 27, 1997. The top of the perforations is at 4,624 feet.

(18) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Wolfcamp formation, said pool to bear the designation of Southwest White City-Wolfcamp Gas Pool. Said Southwest White City-Wolfcamp Gas Pool was discovered by the Inexco Oil Company Southland State Well No. 1 located in Unit J of Section 32, Township 25 South, Range 25 East, NMPM. It was completed in the Wolfcamp formation on April 20, 1981. The top of the perforations is at 9,413 feet.

(19) There is need for the contraction of the Cottonwood Creek-Wolfcamp Gas Pool in Eddy County, New Mexico, by the deletion of certain acreage in order to correct nomenclature.

(20) There is need for certain extensions to the Angell Ranch-Atoka-Morrow Gas Pool, the West Antelope Sink-Abo Pool, the North Dagger Draw-Upper Pennsylvanian Pool, the South Empire-Morrow Gas Pool, the Herradura Bend-Delaware Pool, the North Illinois Camp-Morrow Gas Pool, the East Indian Basin-Morrow Gas Pool, the Indian Basin-Strawn Case No. 11814 Order No. R-10844 -5-

Gas Pool, the Logan Draw-Morrow Gas Pool, the West Lost Tank-Delaware Pool, the Penasco Draw-Upper Pennsylvanian Pool, the East Pierce Crossing-Bone Spring Pool, the Red Lake-Queen-Grayburg-San Andres Pool, the North Runyan Ranch-Abo Gas Pool, the Sand Tank-Morrow Gas Pool, the North Turkey Track-Morrow Gas Pool, and the Willow Lake-Delaware Pool, all in Eddy County, New Mexico.

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by viture of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, contractions, and extensions included herein shall be August 1, 1997.
