**APPLICATION OF THE OIL CONSERVATION DIVISION ("DIVISION")
THROUGH THE SUPERVISOR OF DISTRICT II FOR AN ORDER REQUIRING
THE MOBIL-32 WELL NO. 1 LOCATED IN UNIT D OF SECTION 32,
TOWNSHIP 25-SOUTH, RANGE 1-EAST, DONA ANA COUNTY, NEW MEXICO,
TO BE PROPERLY PLUGGED, AUTHORIZING THE DIVISION TO PLUG SAID
WELL, AND ORDERING A FORFEITURE OF THE PLUGGING BOND.**

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on June 12, 1997, at Santa Fe, New Mexico, before the New Mexico Oil Conservation Division (the "Division") before Examiner David R. Catanach.

NOW, on this 2nd day of September, 1997, the Division Director, having considered the record and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) Jack F. Grimm, N.B. Hunt, George R. Brown and AM Arctic, Ltd. is the last known owner and operator of the Mobil-32 Well No. 1 located in Unit D of Section 32, Township 25 South, Range 1 East, NMPM, Dona Ana County, New Mexico.
- (3) In compliance with Division Rules and Regulations, the operator of said well posted a blanket plugging bond in the amount of \$10,000.00 issued by Travelers Indemnity Company.
- (4) The purpose of said bond is to assure the Division that the subject well will be properly plugged and abandoned when not capable of commercial production.
- (5) Neither the operator, the surety, nor any other interested party introduced any evidence at the Division hearing indicating that this well was not in need of plugging. Such record contains uncontroverted evidence that the well is in need of plugging.

(6) The subject well has not produced hydrocarbon substance or has otherwise been inactive for more than one year, and no permit for temporary abandonment has been requested by the operator or approved by the Division.

(7) By virtue of the failure to use the subject well for a beneficial purpose or to have an approved current temporary abandonment permit, the well is presumed to have been abandoned.

(8) The current condition of the subject well is such that waste may occur, correlative rights may be violated or fresh waters may be contaminated if action is not taken to properly plug and abandon the well.

(9) In order to prevent waste, to protect correlative rights, and to protect fresh waters, the well should be plugged and abandoned in accordance with a program approved by the supervisor of the Artesia District Office of the New Mexico Oil Conservation Division.

(10) At this time, the Division seeks an order directing the operator to plug the well and if the operator fails to do so, make demand upon the surety to pay the Division so much of the bond amount (up to amount of the bond) as is necessary to pay the costs of plugging the well.

IT IS THEREFORE ORDERED THAT:

(1) The operator, is hereby ordered to plug and abandon the Mobil-32 Well No. 1 located in Unit D of Section 32, Township 25 South, Range 1 East, NMPM, Dona Ana County, New Mexico.


(2) The operator, prior to plugging and abandoning the well, shall obtain from the supervisor of the Division Artesia District Office an approved program for said plugging and abandoning and shall notify said Artesia Office of the date and time said work is to commence whereupon the Division may, at its option, witness such work.

(3) Should the operator either fail or refuse to carry out the provisions of this order, the Division shall then take such action as is deemed necessary to have the well properly plugged and abandoned at which time the Division Director shall make demand upon the surety, Travelers Indemnity Company, to pay so much of the bond amount as is necessary to pay the costs of plugging said well.

(4) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
