THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER EXTENDING CERTAIN POOLS IN SAN JUAN AND RIO ARRIBA COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 13, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this $20^{\frac{4}{2}}$ day of February, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, and to the Verde-Gallup Oil Pool, all in San Juan County, New Mexico, to the East Blanco-Pictured Cliffs Pool and the Tapacito-Pictured Cliffs Pool, both in Rio Arriba County, New Mexico, and to the Ballard-Pictured Cliffs Pool and the South Blanco-Pictured Cliffs Pool, both in San Juan and Rio Arriba Counties, New Mexico. Further, that a part of the proposed extension of the South Blanco-Pictured Cliffs Pool was advertised in error and should therefore be dismissed.

IT IS THEREFORE ORDERED:

(a) That the Aztec-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(b) That the East Blanco-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(c) That the Ballard-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 26 NORTH, RANGE 8 WEST, NMPM Section 14: SW/4

(d) That the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(e) That the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 25 NORTH, RANGE 3 WEST, NMPM Section 18: W/2 Section 19: NW/4

> TOWNSHIP 25 NORTH, RANGE 4 WEST, NMPM Section 13: S/2 Section 24: N/2

> TOWNSHIP 26 NORTH, RANGE 5 WEST, NMPM Section 17: All Section 18: All

> TOWNSHIP 27 NORTH, RANGE 7 WEST, NMPM Section 9: All Section 10: All

further, that the proposed extension to the South Blanco-Pictured Cliffs Pool to include therein:

TOWNSHIP 28 NORTH, RANGE 8 WEST, NMPM Section 30: All Section 32: All Section 33: All Section 34: W/2

be and the same is hereby dismissed.

(f) That the Bisti-Lower Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein: -3-Case No. 1380 Order No. R-1130

> TOWNSHIP 25 NORTH, RANGE 11 WEST, NMPM Section 7: SW/4

> TOWNSHIP 25 NORTH, RANGE 12 WEST, NMPM Section 11: S/2 Section 12: All

(g) That the Verde-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 31 NORTH, RANGE 15 WEST, NMPM Section 23: SE/4 Section 24: S/2 Section 25: NE/4

IT IS FURTHER ORDERED:

That the effective date of this order and of all the extensions included herein shall be March 1, 1958.
