APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, ABOLISHING, AND EXTENDING CERTAIN POOLS IN MCKINLEY, RIO ARRIBA, SAN JUAN, AND SANDOVAL COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on August 24, 2000, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 6th day of September, 2000, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Rio Arriba County, New Mexico for the production of gas from the Tertiary Ojo Alamo, Nacimiento and San Jose formations, to be designated the Burro Canyon-Tertiary Pool. The Burro Canyon-Tertiary Pool was discovered by the Mallon Oil Company Jicarilla 28 02 11 Well No. 1 located in Unit C of Section 11, Township 28 North, Range 2 West, NMPM, which was completed in the Ojo Alamo, Nacimiento and San Jose formations on February 7, 1999. The top of the perforations is at 2,788 feet.
- (3) There is need for the creation of a new pool in Rio Arriba County, New Mexico for the production of gas from the Tertiary San Jose, Nacimiento and Ojo Alamo formations, to be designated the Cabresto Canyon-Tertiary Pool. The Cabresto Canyon-

Tertiary Pool will include productive acreage from the Cabresto Canyon-San Jose Pool, the Cabresto Canyon-Nacimiento Pool, and the Cabresto Canyon-Ojo Alamo Pool. This creation is necessary in order to correct pool nomenclature.

- (4) There is need for the creation of a new pool in McKinley County, New Mexico for the production of oil from the Entrada formation, to be designated the Northwest Eagle Mesa-Entrada Oil Pool. The Northwest Eagle Mesa-Entrada Oil Pool was discovered by the Penwell Energy Incorporated Federal 27 Well No. 1 located in Unit J of Section 27, Township 20 North, Range 4 West, NMPM, which was completed in the Entrada formation on February 27, 1998. The top of the perforations is at 5,864 feet.
- (5) There is need for the creation of a new pool in McKinley County, New Mexico for the production of oil from the Entrada formation, to be designated the West Eagle Mesa-Entrada Oil Pool. The West Eagle Mesa-Entrada Oil Pool was discovered by the Penwell Energy Incorporated Eagle Springs 8 Federal Well No. 1 located in Unit B of Section 8, Township 19 North, Range 4 West, NMPM, which was completed in the Entrada formation on March 8, 2000. The top of the perforations is at 5,542 feet.
- (6) There is need for the creation of a new pool in Rio Arriba County, New Mexico for the production of gas from the Tertiary San Jose, Nacimiento and Ojo Alamo formations, to be designated the La Jara Canyon-Tertiary Pool. The La Jara Canyon-Tertiary Pool was discovered by the Mallon Oil Company Jicarilla 29 02 9 Well No. 1 located in Unit L of Section 9, Township 29 North, Range 2 West, NMPM, which was completed in the San Jose formation on March 29, 1999. The top of the perforations is at 1,296 feet.
- (7) There is need for the abolishment of the Cabresto Canyon-Nacimiento Pool in Rio Arriba County, New Mexico to correct pool nomenclature. The productive acreage from this pool will be placed in the Cabresto Canyon-Tertiary Pool.
- (8) There is need for the abolishment of the Cabresto Canyon-Ojo Alamo Pool in Rio Arriba County, New Mexico to correct pool nomenclature. The productive acreage from this pool will be placed in the Cabresto Canyon-Tertiary Pool.
- (9) There is need for the abolishment of the Cabresto Canyon-San Jose Pool in Rio Arriba County, New Mexico to correct pool nomenclature. The productive acreage from this pool will be placed in the Cabresto Canyon-Tertiary Pool.
- (10) There is need for certain extensions to the BS Mesa-Gallup Pool, the East Blanco-Pictured Cliffs Pool, the South Blanco-Tocito Oil Pool, the Carracas-Pictured Cliffs Pool, the Gavilan-Pictured Cliffs Pool, the Gobernador-Pictured Cliffs Pool, the Ice Canyon-Gallup Pool, the Munoz Canyon-Gallup Pool, the Northeast Ojito-Gallup-Dakota Oil Pool, the Rosa-Pictured Cliffs Pool, the Tapacito-Pictured Cliffs Pool, and the Wildhorse-Gallup Pool, all in Rio Arriba County, New Mexico; the Blanco-Mesaverde Pool, the Blanco-Pictured Cliffs Pool, and the South Blanco-Pictured Cliffs Pool, all in

San Juan and Rio Arriba Counties, New Mexico; the Dusenberry-Gallup Pool, the Flora Vista-Fruitland Sand Pool, the Fulcher Kutz-Pictured Cliffs Pool, the South Gallegos-Fruitland Sand-Pictured Cliffs Pool, the Harper Hill-Fruitland Sand-Pictured Cliffs Pool, the South Los Pinos-Fruitland Sand-Pictured Cliffs Pool, the Meadows-Gallup Oil Pool, the Pierre Mesa-Mesaverde Oil Pool, the Twin Mounds-Fruitland Sand-Pictured Cliffs Pool, the Ute Dome-Dakota Pool, and the WAW-Fruitland Sand-Pictured Cliffs Pool, all in San Juan County, New Mexico; and the Rusty-Chacra Pool in San Juan and Sandoval Counties, New Mexico.

(11) The effective date of this order and all creations, abolishments, and extensions included herein should be September 1, 2000.



IT IS FURTHER ORDERED THAT:

- (1) Pursuant to NMSA 1978, Section 70-2-18, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approval from the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations, abolishments, and extensions included herein shall be September 1, 2000.
