THE APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, CONTRACTING, AND EXTENDING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

#### ORDER OF THE DIVISION

#### BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on February 6, 2003, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 12<sup>th</sup> day of February, 2003, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

## FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Chaves County, New Mexico for the production of gas from the Pennsylvanian formation, bearing the designation of Alkali Draw-Pennsylvanian Gas Pool (Pool Code 97244). The Alkali Draw-Pennsylvanian Gas Pool was discovered by the Yates Petroleum Corporation Grynberg "LZ" State Well No. 1 (API No. 30-005-60602) located in Unit I of Section 36, Township 5 South, Range 24 East, NMPM, which was completed in the Pennsylvanian formation on September 4, 2002. The top of the perforations is at 4,878 feet.
- (3) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Atoka formation, bearing the designation of High Lonesome-Atoka Gas Pool (Pool Code 97248). The High Lonesome-Atoka Gas Pool was discovered by the Dominion Oklahoma Texas Exploration &

Production Company Grizzly Adams "13" Federal Com. Well No. 1 (API No. 30-015-32290) located in Unit A of Section 13, Township 16 South, Range 29 East, NMPM, which was completed in the Atoka formation on November 9, 2002. The top of the perforations is at 10,236 feet.

- (4) There is need for the contraction of the Tamano-San Andres Pool (Pool Code 58060) in Eddy County, New Mexico in order to correct nomenclature. The deleted acreage should be placed in the Maljamar-Grayburg-San Andres Pool (Pool Code 43329).
- (5) There is need for extensions to the Boyd-Morrow Gas Pool, the North Cedar Lake-Morrow Gas Pool, the Cedar Lake-Yeso Pool, the Eagle Creek-Strawn Gas Pool, the Grayburg-Atoka Gas Pool, the Loco Hills-Paddock Pool, the Lost Tank-Delaware Pool, the Maljamar-Grayburg-San Andres Pool, the Nash Draw-Delaware Pool, the North Parkway-Wolfcamp Pool, the Seven Rivers Hills-Atoka Gas Pool, and the Shugart-Strawn Pool, all in Eddy County, New Mexico; and the Foor Ranch-Pre-Permian Gas Pool, the Foor Ranch-Wolfcamp Gas Pool, the Milner Lake-Pennsylvanian Gas Pool, the Pecos Slope-Abo Gas Pool, and the Southeast Race Track-Devonian Pool, all in Chaves County, New Mexico.

#### IT IS THEREFORE ORDERED THAT:

(a) A new pool in Chaves County, New Mexico classified as a gas pool for Pennsylvanian production is hereby created and designated as the Alkali Draw-Pennsylvanian Gas Pool (Pool Code 97244), consisting of the following described area:



#### IT IS FURTHER ORDERED THAT:

- Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.
- The effective date of this order and all creations, contractions, and extensions included herein shall be March 1, 2003.
