POOLS IN LEA, CHAVES, EDDY, AND  
ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on November 13, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18<sup>th</sup> day of November, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Seven Rivers formation, said pool to bear the designation Laguna-Seven Rivers Gas Pool. Said Laguna-Seven Rivers Gas Pool was discovered by C. W. Trainer, Jordan Well No. 1, located in the SE/4 NE/4 Section 11, Township 20 South, Range 35 East, NMPM. It was completed May 22, 1958. The top of the perforations is at 4104 feet.

(3) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Pennsylvanian formation, said pool to bear the designation North Shoe Bar-Pennsylvanian Pool. Said North Shoe Bar-Pennsylvanian Pool was discovered by Sinclair Oil & Gas Co., F. J. Danglade Well No. 1, located in the NE/4 SE/4 Section 15, Township 16 South, Range 35 East, NMPM. It was completed August 16, 1958. The top of the perforations is at 10,954 feet.

(4) That there is need for certain extensions to the Acme Pool in Chaves County, New Mexico, and to the Artesia Pool in Eddy County, New Mexico, and to the Blinebry Gas Pool, the Hare Pool, the Hume-Queen Pool, the Jalmat Gas Pool, the Kemnitz-Wolfcamp Pool, and the Tubb Gas Pool all in Lea County, New Mexico, and to the Milnesand-San Andres Pool in Roosevelt County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as a gas pool for Seven Rivers production, be and the same is hereby created and designated as the Laguna-Seven Rivers Gas Pool, consisting of the following described area:

TOWNSHIP 20 SOUTH, RANGE 35 EAST, NMPM  
Section 11: NE/4

(b) That a new pool in Lea County, New Mexico, classified as an oil pool for Pennsylvanian production, be and the same is hereby created and designated as the North Shoe Bar-Pennsylvanian Pool, consisting of the following described area:

TOWNSHIP 16 SOUTH, RANGE 35 EAST, NMPM  
Section 15: SE/4

(c) That the Acme Pool in Chaves County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 8 SOUTH, RANGE 27 EAST, NMPM  
Section 5: N/2

(d) That the Artesia Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 18 SOUTH, RANGE 28 EAST, NMPM  
Section 23: SE/4

(e) That the Blinebry Gas Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM  
Section 19: SE/4  
Section 32: SE/4

(f) That the Hare Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(g) That the Hume-Queen Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(h) That the Jalmat Gas Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 22 SOUTH, RANGE 35 EAST, NMPM  
Section 3: SE/4  
Section 10: SE/4

(i) That the Kemnitz-Wolfcamp Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 16 SOUTH, RANGE 34 EAST, NMPM  
Section 22: NW/4

(j) That the Milnesand-San Andres Pool in Roosevelt County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 8 SOUTH, RANGE 34 EAST, NMPM  
Section 23: NE/4

(k) That the Tubb Gas Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 22 SOUTH, RANGE 38 EAST, NMPM  
Section 31: NE/4 and NE/4 SE/4

IT IS FURTHER ORDERED:
