ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 9, 1959, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW on this 18th day of June, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the West Kutz-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, the Chimney Rock-Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, and to the Verde-Gallup Oil Pool, all in San Juan County; to the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties; and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico. Further, that the proposed extension to the Otero-Gallup Oil Pool in Rio Arriba County, New Mexico, should be dismissed to permit further study.

IT IS THEREFORE ORDERED:

(a) That the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(d) That the Bisti-Lower Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(f) That the Horseshoe-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:
