ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on December 16, 1959, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18th day of December, 1959, the Commission, a quorum being present having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of oil from the Gallup formation, said pool to bear the designation Totah-Gallup Oil Pool. Said Totah-Gallup Oil Pool was discovered by Tennessee Gas Transmission Co., USA Glen H. Callow Well No. 8, located in the SW/4 SE/4, Section 27, Township 29 North, Range 13 West, NMPM. It

was completed September 29, 1959. The top of the perforations is at 5185 feet.

(3) That the proposed creation of the Totah-Dakota Gas Pool in Township 29 North, Range 13 West, NMPM, San Juan County, New Mexico, should be dismissed pending further study.

(4) That there is need for certain extensions to the Gavilan-Pictured Cliffs Pool and the Otero-Gallup Oil Pool, both in Rio Arriba County, New Mexico, to the Aztec-Fruitland Pool, the Aztec-Pictured Cliffs Pool, the Blanco-Pictured Cliffs Pool, the Fulcher Kutz-Pictured Cliffs Pool, the Angels Peak-Gallup Oil Pool, the Bisti-Lower Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, the Verde-Gallup Oil Pool, the Angels Peak-Dakota Pool, the South Los Pinos-Dakota Pool, and the West Kutz-Dakota Pool, all in San Juan County, New Mexico, to the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico, and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in San Juan County, New Mexico, classified as an oil pool for Gallup production, be and the same is hereby created and designated as the Totah-Gallup Oil Pool, consisting of the following-described area:


