ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 a. m. on June 19, 1952 before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," on that portion of the cause postponed for further testimony under Finding No. 5 of Order No. R-156 previously entered herein relating to the the West Kutz-Pictured Cliffs pool.

NOW, on this 16 day of July, 1952, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

1. That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

2. That the West Kutz-Pictured Cliffs Pool, San Juan County, New Mexico, as heretofore classified, defined and described, should be extended to include:

That the application of the Oil Conservation Commission, be, and the same hereby is approved, as follows:

1. That the Boundaries of the West Kutz-Pictured Cliffs pool in San Juan County, New Mexico, be, and the same hereby are extended to include:
