ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 16, 1960, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18th day of March, 1960, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the proposed creation of a new pool for San Andres production in Chaves County, New Mexico, to be designated the Button Mesa-San Andres Pool, should be dismissed at this time due to an error in advertisement.

(3) That there is need for certain extensions to the Brown Pool in Chaves County, New Mexico, to the Atoka-Pennsylvanian Gas Pool, to the Culwin-Queen Pool, to the Empire-Abo Pool, to the East Millman-Queen-Grayburg Pool, and to the East Millman-Seven Rivers Pool, all in Eddy County, New Mexico, and to the Arrowhead Pool, to the Bagley-Pennsylvanian Pool, to the Blinebry Oil Pool, to the Bronco-Mississippian Pool, to the Dollarhide-Queen Pool, to the Drinkard Pool, to the Eumont Gas Pool, to the Justis-McKee Pool, to the South Paddock Pool, and to the South Vacuum-Devonian Pool, all in Lea County, New Mexico, and to the Allison-Pennsylvanian Pool in Roosevelt and Lea Counties, New Mexico.

IT IS THEREFORE ORDERED:


