FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Pine Lake-Pictured Cliffs Pool in Rio Arriba County, New Mexico, to the Aztec-Pictured Cliffs Pool, the Horseshoe-Gallup Oil Pool, and the Verde-Gallup Oil Pool in San Juan County, New Mexico, and to the South Blanco-Pictured Cliffs Pool and the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico.

(d) That the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 26 NORTH, RANGE 6 WEST, NMPM Section 3: E/2

(e) That the Horseshoe-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 31 NORTH, RANGE 16 WEST, NMPM Section 27: SW/4 NW/4 Section 34: NE/4 NW/4, N/2 NE/4, & SE/4 NE/4

(f) That the Verde-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 31 NORTH, RANGE 14 WEST, NMPM Section 28: NW/4 & NW/4 NE/4 Section 30: NE/4 SW/4

That the effective date of this order and of all the extensions included herein shall be April 1, 1960.
