ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 o'clock a.m. on March 16, 1960, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18th day of March, 1960, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Pine Lake-Pictured Cliffs Pool in Rio Arriba County, New Mexico, to the Aztec-Pictured Cliffs Pool, the Horseshoe-Gallup Oil Pool, and the Verde-Gallup Oil Pool in San Juan County, New Mexico, and to the South Blanco-Pictured Cliffs Pool and the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Aztec-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 29 NORTH, RANGE 10 WEST, NMPM
Section 33: SW/4

(b) That the Pine Lake-Pictured Cliffs Pool in Rio

Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 26 NORTH, RANGE 2 WEST, NMPM
Section 29: W/2 & SE/4
Section 32: E/2 & NW/4

(c) That the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 24 NORTH, RANGE 3 WEST, NMPM
Section 18: S/2 (partial)

(d) That the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 26 NORTH, RANGE 6 WEST, NMPM
Section 3: E/2

(e) That the Horseshoe-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 31 NORTH, RANGE 16 WEST, NMPM
Section 27: SW/4 NW/4
Section 34: NE/4 NW/4, N/2 NE/4, & SE/4 NE/4

(f) That the Verde-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 31 NORTH, RANGE 14 WEST, NMPM
Section 28: NW/4 & NW/4 NE/4
Section 30: NE/4 SW/4

IT IS FURTHER ORDERED:


That the effective date of this order and of all the extensions included herein shall be April 1, 1960.
