ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 a. m. August 19, 1952, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 28th day of August 1952, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That a new pool should be created, classified as an oil pool, and designated as the Lovington-Paddock pool, described as:

T. 16S. R. 36 E. NMP^M, Lea County, N. M.

All of Section 36

T. 16 S. R. 37 E. NMPM, Lea County, N. M.

All of Section 31

T. 17 S. R. 36 E. NMPM, Lea County, N. M.

All of Section 1 and Section 12

T. 17 S. R. 37 E. NMPM, Lea County, N. M.

All of Section 6 and 7

(3) That the West Dollarhide-Devonian pool, Lea County, New Mexico as heretofore classified, defined and described, should be extended to include:

T. 24 S. R. 38 E. NMPM

S/2 Section 29, All of Section 32

T. 25 S. R. 38 E. NMPM

N/2 Section 5

(4) That the Monument-Blinebry Pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 19 S. R. 37 E. NMPM

W/2 Section 32

T. 20 S. R. 37 E. NMPM

W/2 Section 5

(5) That the North Warren-Mckee Pool, Lea County, New Mexico as heretofore classified, defined and described, should be extended to include:

T. 20 S. R. 38 E. NMPM

SE/4 Section 7, SW/4 Section 8

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission, be, and the same hereby is approved as follows:

(1) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Lovington-Paddock pool, and described as follows:

T. 16 S. R. 36 E. NMPM, Lea County, N. M.
All of Section 36

T. 16 S. R. 37 E. NMPM, Lea County, N. M.
All of Section 31

T. 17 S. R. 36 E. NMPM, Lea County, N. M.
All of Section 1 and 12.

T. 17 S. R. 37 E. NMPM, Lea County, N. M.
All of Section 6 and 7

(2) That the boundaries of the West Dollarhide-Devonian pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 24 S. R. 38 E. NMPM
S/2 Section 29 and all of Section 32

T. 25 S. R. 38 E. NMPM
N/2 Section 5

(3) That the boundaries of the Monument-Blaine pool, Lea County, New Mexico, be and the same hereby are extended to include:

T. 19 S. R. 37 E. NMPM
W/2 Section 32

T. 20 S. R. 37 E. NMPM
W/2 Section 5

(4) That the boundaries of the North Warren-McKee Pool, Lea County, New Mexico, be and the same hereby are extended to include:

T. 20 S. R. 38 E. NMPM
SE/4 Section 7, SW/4 Section 8
