THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER EXTENDING CERTAIN POOLS IN RIO ARRIBA, SAN JUAN, AND SANDOVAL COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 18, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>20th</u> day of January, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Pine Lake-Pictured Cliffs Pool, to the Devils Fork-Gallup Pool and to the Otero-Gallup Oil Pool in Rio Arriba County, New Mexico, and to the Aztec-Pictured Cliffs Pool, to the Cha Cha-Gallup Oil Pool, to the Gallegos-Gallup Oil Pool, to the Horseshoe-Gallup Oil Pool, to the Kutz-Gallup Oil Pool and to the Totah-Gallup Oil Pool in San Juan County, New Mexico, and South Blanco-Pictured Cliffs Pool, to the Blanco-Mesaverde Pool and to the Escrito-Gallup Oil Pool in Rio Arriba and San Juan Counties, New Mexico, and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval and San Juan Counties, New Mexico. Further that the proposed extension to the Angels Peak-Gallup Oil Pool in San Juan County, New Mexico, and the proposed extension of the Escrito-Gallup Oil Pool in Sections 20 and 29, Township 24 North, Range 7 West, NMPM, Rio Arriba County, New Mexico, should be dismissed.
