ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 4, 1961, at Santa Fe, New Mexico, before Daniel S. Nutter, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this <u>llth</u> day of May, 1961, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, El Paso Natural Gas Company, is the owner and operator of the Federal Lease LC-064198-A, comprising the SE/4 of Section 18, and of Federal Lease No. 025566, comprising the E/2 of Section 19, all in Township 19 South, Range 32 East, NMPM, Lea County, New Mexico.

(3) That the applicant seeks an exception to Rule 309 (a) to permit the transportation of oil produced on the abovedescribed Federal Lease LC-064198-A, prior to measurement, to tank batteries located on the above-described Federal Lease No. 025566.

(4) That it is not proposed to commingle the production from the two above-described Federal Leases.

(5) That approval of the subject application will neither cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

That the applicant, El Paso Natural Gas Company, is hereby granted an exception to Rule 309 (a) to permit the transportation of oil produced on Federal Lease IC-064198-A, comprising the SE/4 of Section 18, prior to measurement, to tank batteries located on Federal Lease No. 025566, comprising the E/2 of Section 19, all in Township 19 South, Range 32 East, NMPM, Lea County, New Mexico.

<u>PROVIDED HOWEVER</u>, That the production from the two abovedescribed leases shall not be commingled.

IT IS FURTHER ORDERED:

That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
