ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 14, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>l6th</u> day of June, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Culwin-Queen Pool, the North Hackberry-Yates Pool, the East Red Lake-Queen Pool, the North Shugart Queen-Grayburg Pool, and the Turkey Tract Pool, all in Eddy County, New Mexico, to the Allison-Pennsylvanian Pool, the Double X-Delaware Pool, the Drinkard Pool, the Justis Tubb-Drinkard Pool, the Lea-Bone Springs Pool, the Paduca-Delaware Pool, the Pearl-Queen Pool, the Saunders Pool, and the East Vacuum-Abo Pool, all in Lea County, New Mexico, and to the South Prairie-Pennsylvanian Pool in Roosevelt County, New Mexico.
