ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on December 13, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18th day of December, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the deletion of certain portions of the Red Mountain-Mesaverde Oil Pool, McKinley County, New Mexico.

(3) That there is need for certain extensions to the Bisti-Lower Gallup Oil Pool, to the Blanco-Pictured Cliffs Pool, to the Cha Cha-Gallup Oil Pool and to the Totah-Gallup Oil Pool in San Juan County, New Mexico, to the Devils Fork-Gallup Oil Pool and to

the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico and to the Blanco-Mesaverde Pool and to the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico.
