ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 o'clock a. m., on December 16, 1952, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 24th day of December, 1952, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Blanco-Mesaverde Pool, San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined and described should be extended to include:

Township 30 North, Range 7 West, NMPM
All of Sections 20 through 29, inclusive;
All of Sections 32 through 36, inclusive;

Township 30 North, Range 6 West, NMPM
All of Sections 18 through 22, inclusive;
All of Sections 27 through 34, inclusive;

Township 32 North, Range 11 West, NMPM
All of Sections 33, 34 and 35.

Township 29 North, Range 10 West, NMPM
All Section 14.

(3) That the Dogie Canyon-Pictured Cliffs Pool, Rio Arriba County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 26 North, Range 6 West, NMPM
All of Section 6.

(4) That the boundaries of the West Kutz-Pictured Cliffs Pool, San Juan County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 27 North, Range 10 West, NMPM
Section 32, W/2.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission, be, and the same hereby is approved, as follows:

(1) That the boundaries of the Blanco-Mesavada Pool, San Juan County, New Mexico, be, and the same hereby are extended to include:

Township 30 North, Range 7 West, NMFM
All of Sections 20 through 29, inclusive;
All of Sections 32 through 36, inclusive;

Township 30 North, Range 6 West, NMFM
All of Sections 18 through 22, inclusive;
All of Sections 27 through 34, inclusive.

Township 32 North, Range 11 West, NMFM
Sections 33, 34 and 35, all.

Township 29 North, Range 10 West, NMFM
Section 14, all.

(2) That the boundaries of the Dogie Canyon-Pictured Cliffs Pool, Rio Arriba County, New Mexico, be, and the same hereby are extended to include:

Township 26 North, Range 6 West, NMFM
Section 6, all.

(3) That the West Kutz-Pictured Cliffs Pool, San Juan County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 27 North, Range 10 West, NMFM
Section 32, W/2.
