ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on November 20, 1962, at Santa Fe, New Mexico, before Elvis A. Utz, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 5th day of December, 1962, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Elvis A. Utz, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That a new gas pool for Queen production should be created in Section 32, Township 18 South, Range 39 East, NMPM, Lea County, New Mexico. This gas pool was discovered by the Brunson-Laughlin State 32 Well No. 1-A on April 10, 1962. The top of the perforations is at 3930 feet.

(3) That a non-standard drilling and gas proration unit comprising Lots 1, 2, 3, and 4 in Section 32, Township 18 South, Range 39 East, NMPM, Lea County, New Mexico, and consisting of 103.52 acres should be approved and dedicated to the Brunson-Laughlin State 32 Well No. 1-A located 330 feet from the North line and 410 feet from the East line of said Section 32.

(4) That a non-standard gas well location 330 feet from the North line and 410 feet from the East line of Section 32,

Township 18 South, Range 39 East, NMPM, Lea County, New Mexico, should be approved for the Brunson-Laughlin State 32 Well No. 1-A.

(5) That approval of the subject application will neither cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

(1) That a new gas pool for Queen production is hereby created and designated the Texline-Penrose Gas Pool. The horizontal limits of said pool shall be Lots 1, 2, 3, and 4 in Section 32, Township 18 South, Range 39 East, NMPM, Lea County, New Mexico.


(2) That a non-standard drilling and gas proration unit comprising Lots 1, 2, 3, and 4 in Section 32, Township 18 South, Range 39 East, NMPM, Lea County, New Mexico, containing 103.52 acres is hereby approved and dedicated to the Brunson-Laughlin State 32 Well No. 1-A, located 330 feet from the North line and 410 feet from the East line of said Section 32.

(3) That a non-standard gas well location 330 feet from the North line and 410 feet from the East line of Section 32, Township 18 South, Range 39 East, NMPM, Lea County, New Mexico, is hereby approved for the Brunson-Laughlin State 32 Well No. 1-A.


(4) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
