ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on July 10, 1963, at Santa Fe, New Mexico, before Elvis A. Utz, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this <u>17th</u> day of July, 1963, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Elvis A. Utz, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the East Bisti Unit Agreement has been approved by the Commission by Order No. R-2521; that the East Bisti Unit Area comprises 17,812 acres, more or less, of Federal, State, and Indian lands in Townships 24 and 25 North, Ranges 9, 10, and 11 West, NMPM, San Juan County, New Mexico, as more fully described in said order.

(3) That the applicant, Skelly Oil Company, seeks permission to institute a waterflood project in the Bisti Lower-Gallup Oil Pool in the East Bisti Unit Area by the injection of water into the Gallup formation through 34 wells located within said unit area.

(4) That the wells in the project area are in an advanced state of depletion and should properly be classified as "stripper" wells.

(5) That the proposed waterflood project is in the interest of conservation and should result in recovery of otherwise unrecoverable oil, thereby preventing waste. -2-CASE No. 2849 Order No. R-2524

(6) That the subject application should be approved and the project should be governed by the provisions of Rule 701 of the Commission Rules and Regulations.

IT IS THEREFORE ORDERED:

(1) That the applicant, Skelly Oil Company, is hereby authorized to institute a waterflood project in the Bisti Lower-Gallup Oil Pool in the East Bisti Unit Area, San Juan County, New Mexico, by the injection of water into the Gallup formation through the following-described 34 wells:
