## BEFORE THE OIL CONSERVATION COMMISSION OF THE STATE OF NEW MEXICO

IN THE MATTER OF THE HEARING CALLED BY THE OIL CONSERVATION COMMISSION ON ITS OWN MOTION TO CONSIDER THE REVISION OF RULE 1126 OF THE COMMISSION RULES AND REGULATIONS.

#### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on July 17, 1963, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 30th day of July, 1963, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That in order to expedite the posting and printing of the oil proration schedule and in order to standardize the filing dates of forms concerning the oil proration schedule, Rule 1126 of the Commission Rules and Regulations should be amended to provide that one copy of Form C-127 shall be filed by the oil producer with the appropriate District Office of the Commission not later than the 10th day of the month preceding the month for which oil well allowable changes are requested.
- (3) That adoption of the proposed rule change will enable the Oil Conservation Commission to more efficiently and effectively administer the laws of the State of New Mexico concerning the conservation of oil and gas and the prevention of waste.

### IT IS THEREFORE ORDERED:

(1) That Rule 1126 of the Commission Rules and Regulations

is hereby amended to read in its entirety as follows:

RULE 1126. OIL PRODUCERS ALLOWABLE CHANGE (Form C-127)

One copy of Form C-127 shall be filed by the oil producer with the appropriate District Office of the Commission not later than the 10th day of the month preceding the month for which oil well allowable changes are requested.

- (2) That Commission Form C-127, Oil Producers Request For Allowable Change, is hereby revised to conform to Exhibit "A" attached hereto and made a part hereof.
- (3) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
