LIMITS OF CERTAIN POOLS IN  
LEA, AND ROOSEVELT COUNTIES,  
NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 13, 1965, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 15th day of January, 1965, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and subject matter thereof.

(2) That there is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of gas from the San Andres formation, said pool to bear the designation of West Bluitt-San Andres Gas Pool. Said West Bluitt-San Andres Gas Pool was discovered by Shell Oil Company, Federal "BL" No. 8-1, located in Unit A of Section 8, Township 8 South, Range 37 East, NMPM. It was completed in San Andres on October 5, 1964. The top of perforations is 4311 feet.

(3) That there is need for the extension of the vertical limits of the Lynch-Yates Pool in Lea County, New Mexico, to thereby include the Seven Rivers formation and change the pool name from Lynch-Yates Pool to the Lynch Yates-Seven Rivers Pool.

(4) That there is need for the extension of the vertical limits of the Middle Lynch-Yates Pool in Lea County, New Mexico, to thereby include the Seven Rivers formation and change the pool name from Middle Lynch-Yates Pool to the Middle Lynch Yates-Seven Rivers Pool.

(5) That there is need for the extension of the vertical limits of the North Lynch-Yates Pool in Lea County, New Mexico, to thereby include the Seven Rivers formation and change the pool name from North Lynch-Yates Pool to the North Lynch Yates-Seven Rivers Pool.

(6) That there is need for the extension of the vertical limits of the Teas-Yates Pool in Lea County, New Mexico, to thereby include the Seven Rivers formation and change the pool name from Teas-Yates Pool to the Teas Yates-Seven Rivers Pool.

(7) That there is need for the extension of the vertical limits of the West Teas-Yates Pool in Lea County, New Mexico, to thereby include the Seven Rivers formation and change the pool name from West Teas-Yates Pool to the West Teas Yates-Seven Rivers Pool.

(8) That there is need for certain extensions to the Bagley-Pennsylvanian Pool, the West Jal-Strawn Gas Pool, the South Lane-Pennsylvanian Pool, the Lusk-Strawn Pool, the Oil Center-Blinbry Pool, the Skaggs-Drinkard Pool, the West Teas-Yates Pool, and the Vacuum-Wolfcamp Pool, all in Lea County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Roosevelt County, New Mexico, classified as a gas pool for San Andres production, is hereby created and designated as the West Bluitt-San Andres Gas Pool, consisting of the following described area:

TOWNSHIP 8 SOUTH, RANGE 37 EAST, NMPM  
SECTION 8: NE/4

(b) Extend the vertical limits of the Lynch-Yates Pool in Lea County, New Mexico, to include the Seven Rivers formation and rename the Lynch-Yates Pool to Lynch Yates-Seven Rivers Pool.

(c) Extend the vertical limits of the Middle Lynch-Yates Pool in Lea County, New Mexico, to include the Seven Rivers formation and rename the Middle Lynch-Yates Pool to Middle Lynch Yates-Seven Rivers Pool.

(d) Extend the vertical limits of the North Lynch-Yates Pool in Lea County, New Mexico, to include the Seven Rivers formation and rename the North Lynch-Yates Pool to North Lynch Yates-Seven Rivers Pool.

(e) Extend the vertical limits of the Teas-Yates Pool in Lea County, New Mexico, to include the Seven Rivers formation and rename the Teas-Yates Pool to Teas Yates-Seven Rivers Pool.

(f) Extend the vertical limits of the West Teas-Yates Pool in Lea County, New Mexico, to include the Seven Rivers formation and rename the West Teas-Yates Pool to West Teas Yates-Seven Rivers Pool.

(g) That the Bagley-Pennsylvanian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(i) That the South Lane-Pennsylvanian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 11 SOUTH, RANGE 34 EAST, NMPM  
SECTION 6: E/2 SW/4

(j) That the Lusk-Strawn Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 19 SOUTH, RANGE 32 EAST, NMPM  
SECTION 5: NW/4  
SECTION 19: NW/4

(k) That the Oil Center-Blinebry Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 21 SOUTH, RANGE 36 EAST, NMPM  
SECTION 11: W/2 W/2

(l) That the Skaggs-Drinkard Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

SECTION 10: NW/4  
SECTION 12: NE/4

(m) That the West Teas-Yates Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:


