ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 17, 1953, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 10th day of April 1953, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the Skaggs Pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include;

Township 20 South, Range 37 East, NMPM S/2 Section 12

(3) That the East Lovington-Pennsylvanian Pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 16 South, Range 37 East, NMPM All Section 31

(4) That the crossroads Pool, Lea County, New Mexico, as hereto fore classified, defined and described, should be extended to include;

Township 9 South, Range 36 East, NMPM SW/4 Section 23

(5) That the Artesia Pool, Eddy County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 18 South, Range 28 East, NMPM All Section 12 and NE/4 Section 14

(6) That the following described area should be deleted from the Loco Hills Pool, Endy County, New Mexico, as heretofore classified, defined and described:

Township 18 South, Range 28 East, NAPM All Section 12

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and the same hereby is approved as follows:

(1) That the boundaries of the Skaggs Pool, Lea County, New Mexico, be and the same hereby are extended to include:

Township 20 South, Range 37 East, NMPM S/2 Section 12

(2) That the boundaries of the East Lovington-Pennsylvanian Pool, Lea County, New Mexico, be, and the same hereby are extened to include:

Township 16 South, Range 37 East, NMPM All Section 31

(3) That the boundaries of the Crossraods Pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Township 9 South, Range 36 East, NMPM SW/4 Section 23

(4) That the boundaries of the Artesia Pool, Eddy County, New Mexico, be, and the same hereby are extended to include:

Township 18 South, Range 28 East, NMPM All Section 12 And NE/4 Sect. 14.

(5) That the boundaries of the Loco Hills Pool, Eddy County, New Mexico, be and the same hereby are contracted to delete therefrom the following:

Township 18 South, Range 28 East, NMPM All Section 12
