THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES, EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on October 19, 1966, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>26th</u> day of October, 1966, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new oil pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of Burton-Delaware Pool. Said Burton-Delaware Pool was discovered by J. C. Williamson, Yates Federal No. 1, located in Unit P of Section 7, Township 20 South, Range 29 East, NMPM. It was completed in Delaware on June 23, 1966. The top of perforations is 3189 feet.

(3) That the proposed creation of a new pool in Section 3, Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico, -2-CASE No. 3478 Order No. R-3139

for the production of oil from the Delaware formation should be <u>dismissed</u> pending further study.

(4) That there is need for the creation of a new oil pool in Eddy County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of North Millman-San Andres Pool. Said North Millman-San Andres Pool was discovered by Martin Yates III, State N&C No. 1, located in Unit M of Section 6, Township 19 South, Range 29 East, NMPM. It was completed in San Andres on March 20, 1966. The top of perforations is 2612 feet.

(5) That there is need for certain extensions to the Cato-San Andres Pool in Chaves County, New Mexico, the Chaveroo-San Andres Pool in Chaves and Roosevelt Counties, New Mexico, the North Benson Queen-Grayburg Pool, the Cemetary-Morrow Gas Pool, the Corral Canyon-Delaware Pool, the Eagle Creek-San Andres Pool, the Grayburg-Jackson Pool, and the Shugart-Delaware Pool, all in Eddy County, New Mexico, the North Bagley-Middle Pennsylvanian Pool, the Drinkard Pool, the Pearl-Queen Pool, and the Wantz-Abo Pool, all in Lea County, New Mexico, and the Bluitt-San Andres Gas Pool in Roosevelt County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production, is hereby created and designated as the Burton-Delaware Pool, consisting of the following-described area:

> TOWNSHIP 20 SOUTH, RANGE 29 EAST, NMPM Section 7: SE/4 SE/4

(b) That the proposed creation of a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production, designated as the Ingle Wells-Delaware Pool, consisting of the followingdescribed area:

> TOWNSHIP 24 SOUTH, RANGE 31 EAST, NMPM Section 3: NW/4 NW/4

is hereby dismissed.

(c) That a new pool in Eddy County, New Mexico, classified as an oil pool for San Andres production, is hereby created and designated as the North Millman-San Andres Pool, consisting of the following-described area:

> TOWNSHIP 19 SOUTH, RANGE 29 EAST, NMPM Section 6: SW/4 SW/4

(d) That the North Bagley-Middle Pennsylvanian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

> TOWNSHIP 11 SOUTH, RANGE 33 EAST, NMPM Section 21: NW/4

(e) That the North Benson Queen-Grayburg Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

> TOWNSHIP 18 SOUTH, RANGE 30 EAST, NMPM Section 31: E/2 NE/4 Section 32: S/2 NW/4

(f) That the Bluitt-San Andres Gas Pool in Roosevelt County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

> TOWNSHIP 8 SOUTH, RANGE 37 EAST, NMPM Section 5: All

(g) That the Cato-San Andres Pool in Chaves County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 8 SOUTH, RANGE 30 EAST, NMPM Section 10: E/2 and NW/4 Section 11: N/2

(h) That the Cemetary-Morrow Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 20 SOUTH, RANGE 25 EAST, NMPM Section 16: W/2

(i) That the Chaveroo-San Andres Pool in Chaves and Roosevelt Counties, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(k) That the Drinkard Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(1) That the Eagle Creek-San Andres Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(m) That the Grayburg-Jackson Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(o) That the Shugart-Delaware Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(p) That the Wantz-Abo Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:
