THE APPLICATION OF THE COMMISSION UPON ITS OWN MOTION FOR AN ORDER CALLING FOR THE CREATION OF NEW POOLS, AND FOR EXTENSIONS TO OR DELETIONS FROM EXISTING POOLS IN LEA AND CHAVES COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 17, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 15th day of April, 1954, the Commission, a quorum being present, having considered the testimony presented and exhibits received at said hearing,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.
- (2) That the Anderson Ranch-Pennsylvanian Oil Pool should be established in Lea County, New Mexico, as advertised.
- (3) That extensions should be approved as advertised for the Crossroads-Pennsylvanian Pool, the Denton-Wolfcamp Pool, the Langlie-Mattix Pool, the Lazy 'J' Pool and the Monument-Paddock Pool, all of which are in Lea County, New Mexico; and to the Drickey-Queen Pool in Chaves County, New Mexico.
- (4) That the area as described in Section(e) of subject case be deleted from the Cooper-Jal Pool in Lea County, New Mexico.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and it hereby is approved, as follows:

Enterel - 4-24-54

Order No. R-419

(a) That a new pool be created in Lea County, New Mexico, designated as the Anderson Ranch-Pennsylvanian Pool for production of oil from the Pennsylvanian, and described as:

Township 16 South, Range 32 East Sections 10, 11, 14 and 15, all

(Creation of this pool is based upon the discovery made by Continental Oil Company in its State Q-15 Well No. 1-P, SW/4 NE/4 Section 15, Township 16 South, Range 32 East, NMPM, Lea County, New Mexico, producing oil from the Pennsylvanian with top of casing perforations 12, 370')

(b) That the Crossroads-Pennsylvanian Pool boundary as heretofore classified, defined and described, should be extended to include therein:

Township 9 South, Range 36 East All of Section 30

(c) That the Denton-Wolfcamp Pool boundary as heretofore classified, defined and described, should be extended to include therein:

Township 14 South, Range 37 East, SW/4 Section 25

(d) That the Langlie-Mattix Pool boundary as heretofore classified, defined and described, should be extended to include therein:

Township 25 South, Range 37 East NE/4 NW/4 Section 18

(e) That the Cooper-Jal Pool boundary as heretofore classified, defined and described, should be contracted so as to exclude the following area:

Township 25 South, Range 37 East NE/4 NW/4 Section 18

(f) That the Lazy 'J' Pool boundary as heretofore classified, defined and described, should be extended to include:

Township 13 South, Range 33 East E/2 Section 20; W/2 Section 21

(g) That the Monument-Paddock Pool boundary as heretofore classified, defined and described, should be extended to include:

Township 20 South, Range 37 East E/2 Section 7

(h) That the Drickey-Queen Pool boundary (Chaves County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 14 South, Range 31 East E/2 Section 10; W/2 Section 11
